Hatcher made a motion to approve the 2019-2020 School Calendar. Schick seconded the motion. Motion carried una. (7-0)

Hatcher made a motion to approve Update 112. Duggan seconded the motion. Motion carried una (7-0)

Hatcher made a motion that pursuant to District Policy CCGB (Local) the Board of Trustees accept the Application of Lily Solar, LLC for an Appraised Value Limitation on Qualified Property; to authorize the Superintendent to review the Application for completeness and submit to the Comptroller; and further to authorize the Superintendent to enter into any agreement to extend the deadline for Board action beyond 150 days, subject to Board ratification. Hatcher made a motion to notify the Texas Education Agency that allowing Texas Leadership Charter Academy to expand its geographic boundaries for grades 7-12 will adversely impact the financial status of our school district. Duggan seconded the motion. Motion carried una. (7-0)
