 - Starting strong tonight with an incredible showing from our students at EPHS: The Class of 2026 has 10 National Merit Semifinalists! Twelfth graders Alice Ling, Jessica Cao, Vivian Nguyen, Gwendolyn Glasrud, Kotono Kazama, Syon Shetty, Devanshu Shah, Ojas Sonbarse, Alexander Wycoff and Eshaan Salunke are among only 16,000 Semifinalists out of the 1.6 million students who took the Preliminary Scholastic Assessment Test (PSAT) last October. These Eagles now have the opportunity to continue in the National Merit Scholarship competition, in which approximately 7,500 scholarships will be awarded. Join me in congratulating these students on their incredible achievement!
 - Earlier this month during an EPHS girls volleyball game, Sarah Wilhite Parsons ('13) was honored as one of the inductees to the Eden Prairie Schools Hall of Fame! During her time at EPHS, Parsons led the Eagles to their first-ever Class AAA state volleyball title, earned back-to-back Gatorade Player of the Year honors for Minnesota in 2011 and 2012, and was twice named to the Minnesota State Volleyball All-Tournament Team. While attending the University of Minnesota, Parsons made history in 2016 as the first Gopher to be named AVCA, ESPNW, and Big Ten Player of the Year. Her professional volleyball career has taken her around the world, and she was happy to be back in Eden Prairie celebrating her accomplishments! We'll be celebrating Sarah and 19 other exceptional inductees to our Hall of Fame on October 4 at the Eagle Excellence Showcase. As a preview of the night and to highlight Sarah since she can't be in attendance, we'd like to debut her Hall of Fame inductee video that will be shown at the Showcase.
 - There are still tickets available for the Showcase! It's going to be an awesome night of community and celebration. You can find the link to tickets on our website.
 - After the recent tragedy at Annunciation Catholic Church and School in Minneapolis, EPHS student leaders wondered what action they could take to express their support. The resulting project, Messages that Matter, involved EPHS students writing thousands of cards. A couple weeks ago, student leaders from across EPHS delivered blank cards to classrooms, where all students had the opportunity to write messages of support and encouragement to students, staff and community members at Annunciation. Student leaders are now determining how the notes can best be shared with the Annunciation community considering the school's evolving needs. Thank you, EPHS students, for contributing to your community.
 - Also, this month, around 30 EPHS students performed and produced "Trajectories," a 41-year-old tradition of the drama department that features skits and dances entirely written, directed and choreographed by students.

- This year's show featured six dances and nine skits, ranging from mystery to comedy to drama. It's so fun to see Eagles carrying forward a longstanding tradition that celebrates student creativity!
- September is School Board Recognition Month! Hopefully you saw the post we did on social media and the
 acknowledgements in Staff and Parent Post. I just wanted to take a moment to thank you for helping guide our
 district and support the success of our students and staff. We have a unique but effective structure here in Eden
 Prairie, where you give me a lot more latitude to make decisions that happens in other districts—but that also
 comes with a lot more accountability. So, thank you for the trust you place in me and all of our district staff, for
 the connections you build across our community, and for your deep care for each of our students. (And I'm not

- c. BMD 3.2 Delegation to the Superintendent: The School Board will instruct the Superintendent through written policies that prescribe the district ends to be achieved and describe district situations and actions to be avoided, allowing the Superintendent to use any reasonable interpretation of these policies.
- d. BMD 3.3 Superintendent Accountability & Performance: The School Board will view the Superintendent performance as identical to district performance on the School Board's Ends and Executive Limitations policies.

 - b. GP 4.5 School Board Members Code of Conduct: The School Board commits itself and its members to ethical, businesslike, and lawful conduct, including proper use of authority and appropriate decorum when acting as School Board members.
 - c. GP 4.6 Process of Addressing School Board Member Violations: The School Board and each of its members are committed to faithful compliance with the provisions of the School Board's policies. The School Board recognizes that alleged willful and or continuing policy violations must be addressed. Each member is responsible for promptly initiating the process outlined below.
 - d. GP 4.7 School Board Committee Principles: School Board committees, when used, will be assigned so as to reinforce the wholeness of the School Board's job and so as never to interfere with delegation from School Board to Superintendent. Accordingly:
 - e. GP 4.8 School Board Committee Structure: A School Board-level committee is created by a majority vote of the School Board to assist in the completion of School Board business. Each committee submits a yearly plan of action to the Board, submits minutes of meetings in a timely manner, and reports progress during Board business meetings. The only School Board committees are those that are set forth in this policy.
 - f. GP 4.10 Operation of the School Board Governing Rules: The purpose of this policy is to provide governing rules for the conduct of meetings of the School Board. An orderly School Board meeting allows School Board members to participate in discussion and decision of school district issues. Rules of order allow School Board members the opportunity to review school-related topics, discuss school business items, and bring matters to conclusion in a timely and consistent manner.
