Courthouse Sanitary Sewer - Waiting on spring to get here for repairs to sprinkler system and plant grass.

Accident damage to center restrooms at the Fairgrounds – Insurance money has been received and an expense account line item number has been set up to pay bills from. Funds for this project have been moved from the 2022 budget to the 2023 budget. Masonry work is complete. I will be meeting with Great Lakes Fence the first part of next week to get that portion of the project moving along. Interior work to be completed by maintenance will begin ASAP.

Tower project for 911 – Foundation work is complete. The crane is scheduled to arrive on 4/19. Tower is scheduled to arrive on 4/20 and will be erected in the following days.

Old DHHS Building Renovation – Work is ongoing with the demolition/tear out complete. We are in the priming/ painting stage. Flooring has been ordered and will be installed when it arrives.

Building Automation Upgrade – Control Solutions is working to get the new controllers programed for installation. Plaza Pool is done and project is ongoing.

Replacement of controls at new terminal for roof top units – Materials have been received and programed. Installation will take place while work is being done on the airfield.

Sunken Lake House Repairs- This project is complete.

MDOT Building- With the new heat exchanger installed it was discovered that none of the VAV units were working. I am waiting on prices for repair. I have received two options for repair from Control Solutions. The first option is to replace parts necessary with Trane equipment in the amount of \$13,335.00. The second option is to remove the existing Trane system and replace it with a new VVT damper system programed by Control Solutions. The cost of this option would be \$13,685.00. It would be my recommendation to have the system switched over to Control Solutions which would eliminate the need for having Trane travel here for any programing issues. Cost would be \$13,685.00 and would also have the old humidifiers removed and the system tested and balanced.

Spring Grounds Clean-Up – Work will begin next week.

Getting Fairgrounds ready for camping season – Work will begin next week.
