

NOTICE FOR SUBMITTING BAKERY BIDS

The Board of Education of Independent School District #595, located in East Grand Forks, Minnesota is now accepting bakery bids for the National School Lunch Program, School Breakfast Program, and any additional Child Nutrition Programs for the 2025-2026 school year. This time period is defined as July 1, 2025 – June 30, 2026. The original awarded bid can be renewed for up to two (2) additional one-year terms following the original award period if mutually agreed upon with the awarded vendor and ISD #595.

Bids shall be submitted in writing to the District Administration Office no later than **June 30, 2025 at 10 am.**

Bids will only be accepted in writing. Electronic mail, telephone, facsimile, and telegraphic bids will not be accepted. "Bakery Bid" should be written on the lower left-hand corner of the sealed envelope.
