AMENDMENT

INTERLOCAL COOPERATION AGREEMENT FOR SCHOOL RESOURCE OFFICERS

This INTERLOCAL COOPERATION AGREEMENT FOR SCHOOL RESOURCE OFFICERS, hereinafter referred to as "Agreement", made by and between Town of Little Elm, a Home Rule City of the State of Texas, hereinafter referred to as the "TOWN", and the DENTON INDEPENDENT SCHOOL DISTRICT, an Independent School District, hereinafter referred to as the "DISTRICT" dated July 25, 3023. Is hereby amended to add One (1) additional School Resource Officer as follows:

**III.     PAYMENT FOR SERVICES**

- A. The DISD shall pay the TOWN the sum of \$731,373.493 for services and Capital cost associated with adding two SRO's to the current program. Quarterly payments in the amount of \$182,843.37 should be paid beginning no later than 15<sup>th</sup> of the month in July and October of 2023 and January and April of 2023. The annual amount and vehicle cost calculation is set forth in Exhibit "A" attached hereto and incorporated by reference herein. The calculation is based upon 75% of the cost of the current salary and benefits of (6) full time officers, (1) full time Sergeant and 100% of the salary and benefits for the SRO stationed at Cheek middle school. Capital cost include replacement of unit 1609 (minus auction value), the outfitting of the SRO (\$27,350.00) stationed at Cheek middle School and providing the funding of the required patrol vehicle (\$103,548.00) for Cheek middle school SRO.
