Discussion: Moulton – Hybrid plan makes serving large quantities of students possible without having to sacrifice health and safety. Smecca – Anything we can do to get by at this point is critical. Masel – She is not panicked yet but concerned and doesn't feel like there are any other options.

Unanimous in favor.

5) Discuss and Consider approval to submit to TEA the Galveston ISD Asynchronous Educational Plan for the 2020-2021 school year. 8:59 - 9:03 Motion by Masel. Second by Lakin Discussion: Moulton – We are required to submit this waiver. We are demonstrating that we are meeting the needs of our kids with the plan we are using now. Wagner – She supports the plan. O'Neal – He applauds the format we have in place and is in support of it. Brown – He wants to clarify that this is a waiver or submission of a plan. Moulton - It is a submission of a plan. Unanimous in favor.

6) Board Comments 9:03 - 9:19

Smecca - He feels the more conversation about the middle school alignment, the better. Masel – ditto Johnny. Our plate is really full right now. We really do want to hear from the public. Smecca - is going to put it on his trustee facebook page to let people know it's being talked about. O'Neal - We are doing a great job educating our students. For future agenda items, he would like to know what course each of the coaches are teaching this year and what did they teach in the previous years? How many coaches do we have this year and where are they coaching? How many coaches did we have last year and what did they teach last year? Have we filled all of the coaching slots and if not, what slots are vacant and when will they be filled if they are going to be filled? This information should be readily available and have information to the board before the next meeting preferably by the 10th or the 11th of September. Jobe - Equity of opportunity in our schools. The quality and caliber of our principals is something to be commended. Also, public input is going to be very important. This year could be a good transition year because everything is upside down already but he would like to hear from the public. Wagner - She commented on restructure of middle schools and would like to thank teachers and administrators for all of their hard work. Brown – There is equity in terms of outcomes so that no matter where they come from, they hit the ground running. We need to watch assessments very closely and be ready to address them. Thanks to everyone for their hard work.
