4:30	Changes maximum investment period for large sums of money from three to ten years AND changes the threshold for WHERE and with WHOM districts may invest their money	Approve as presented
4:170	Changes requirements on the availability of AEDs throughout the day when people are present	Approve as presented
5:10	Holds districts accountable if using AI in hiring process leads to discrimination; also prevents discrimination based on reproductive birth rights	Approve as presented
5:20	Adds family responsibilities and reproductive health decisions to things someone cannot be harassed about and provides it in writing to formalize the expectation	Approve as presented
5:90	Changes expectation of filing a written DCFS report on top of filing a digital or phone report	Approve as presented
5:120	Changes guidance counselor to school counselor in the language AND stipulates that counselors should not accept gifts from colleges and universities (such as travel to and from the universities, etc.)	Approve as presented

6:270	More verbiage changes from guidance counselors to licensed school counselors	Approve as presented
7:10	Adds language on equal opportunities for extra-curricular participation to include that we cannot discriminate based on military service, unfavorable military discharge, or reproductive health decisions. Also includes that any student can file a Title IX complaint.	Approve as presented
