RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION
HELD ON APRIL 8, 2025

BE IT RESOLVED by the School Board (the "Board") of Independent School District No. 742 (St. Cloud Area Schools) (the "District"), as follows:

1. It is hereby found, determined and declared that the special election of the voters of this District held on April 8, 2025, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Cast, a total of 6,465 voters of the District voted at said election on the question of the Approval of School Building Bonds (Question 1), of which 4,017 voted in favor, 2,446 voted against the same.

3. Question 1, having received the approval of at least a majority of such votes, is hereby declared to have passed.

4. As specified in the attached Abstract and Return of Votes Cast, a total of 6,465 voters of the District voted at said election on the question of the Approval of School Building Bonds (Question 2), of which 3,503 voted in favor, 2,945 voted against the same. The passage of Question 2 is contingent upon the passage of Question 1.

5. Question 2, having received the approval of at least a majority of such votes, is hereby declared to have passed.

6. The school district clerk is hereby directed to certify the results of the special election to the County Auditors of Benton County, Sherburne County, Stearns County and Wright County.

7. The school district clerk is further directed to notify the Commissioner of Education of the results of the special election and to provide the certified vote totals for the ballot question in written form within 15 days after the results of the election have been certified by the Board.
