Treasurer's Report: Jim Downs reported that the PEF regular checking account balance as of September 30, 2011 was \$30,367.52 and the PEF website checking account had a balance of \$8,137.52 for the same time period. Jim reported that the PEF has bills to pay in the amount of \$140 for Wall of Fame programs and \$105 for raffle tickets and signs. Motion was made by Stupek to approve the Treasurer's report and pay bills and seconded by Ishmael. All yes.

Committee Reports:

- 1) **Scholarship** Dr. Lett reported the PEF received 2 new scholarship donations this past month. He will look into the distribution manner of these funds and will report back to the PEF at our next meeting.
- 2) **Courtyard** Nothing to discuss at this time.
- 3) **Mini-Grants** Recommendations for mini-grant funding were made by Dr. Lett and Dennis Ishmael totaling \$19,760.31 which consisted of technology based and non-technology based requests made by several of the school district's teachers. Funding for these mini-grants will be accomplished

- through combined finances from the school district, PEF and other sources. Dunseth made a motion to accept the mini-grants recommended and motion was seconded by Weideman. All Yes.
- 4) **Publicity-** (**IPAD2 RAFFLE**)Dr. Lett reported that receipts for the PEF's IPAD2 raffle are estimated at \$1,637. Bills yet to be paid are \$105 for raffle tickets and signs and \$499 for the IPAD. (**SCORING FOR EDUCATION**) 6 boys and girls basketball games (3 each) have been selected for Scoring for Education bidding. Girl's games will be December 1 (Teutopolis), January 17 (Litchfield) and February 2 (EAWR). Boys' games will be December 6 (Shelbyville), December 13 (Nokomis) and February 18 (Vandalia).
