The time has come to make our voices heard and oppose legislation that, if passed, would shorten the tenure process by one year for probationary employees.

HB 5060 is scheduled to be heard in the House Elementary & Secondary Education: Administration, Licensing, & Charter Schools Committee at 2 p.m. today (February 16). It is part of a series of bills that have been introduced that propose changes to the educator evaluation process.

We need your support to show the committee members that this process would be most appropriate for comprehensive review by the Performance Evaluation Advisory Council (PEAC), rather than piecemeal legislative proposals.
