### RESOLUTION

Approving Memorandum of Understanding Between Browning Public School District #9 and Blackfeet Tribal Health System

No. <u>564-2024</u>

- WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Nation pursuant to the Constitution and By-Laws for the Blackfeet Tribe of the Blackfeet Indian Reservation of Montana, 1935 and amendments thereof, and
- WHEREAS, The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, health, education, welfare and resources of the Blackfeet Indian Reservation, and
- WHEREAS, The Blackfeet Tribal Business Council is empowered to negotiate with federal, state and local governments on behalf of the Tribe pursuant to Article VI, Section 1(a) of the Constitution of the Blackfeet Tribe, and
- WHEREAS, Blackfeet Tribal Business Council received a proposed Memorandum of Understanding (MOU) between the Browning Public Schools #9 and the Blackfeet Tribal Health System, and

WHEREAS, The MOU provides for the development and implementation of a program that provides the schools with medical, dental, nutrition and mental health/substance use consultation and services through direct services by health professionals and telehealth consultation as necessary, and

**WHEREAS,** The Blackfeet Tribal Business Council has reviewed the MOU and desires to now approve the MOU as presented, now

## THEREFORE, BE IT RESOLVED:

- That the Blackfeet Tribal Business Council hereby agrees to the terms and conditions set forth in the Memorandum of Understanding between the Browning Public Schools #9 and the Blackfeet Tribal Health System, of which is attached hereto and incorporated into this resolution by this reference.
- 2. That the Chairman or Vice-Chairman in the Chairman's absence and Secretary of the Blackfeet Tribal Business Council are hereby authorized to sign this Resolution and any other documents to effectuate the purposes of this Resolution.
