## **Summer School Services**

- Hours per day:
  - o 9:00am 3:00pm for students
  - o 8:30am 3:30pm for teachers
- Reading Intervention Curriculum and Math Intervention Curriculum will be provided by the school
- Stem Curriculum:
  - o Robotics provided by the school
- Incentives
- The students will be taking field trips to Glacier Park and neighboring cities on Fridays for outdoor challenges, games, museums, etc.

#### **Student Eligibility**

 Students within the boundaries of Browning Public Schools will be identified for Title I summer school services described in this proposal based on achievement tests, teacher referrals and recommendations based on objective, educationally related criteria, and grades.



#### **Teacher Staffing**

FACTS Ed will provide four (4) Title I Instructors.


### Invoicing
