Based on a thorough review and analysis of the submitted proposals and their accompanying qualification statements, bonds and other provided information, PBK Facility Consulting Division hereby recommend that the Board of Trustees of Galveston Independent School District enter into a formal agreement with Remedy Roofing for Re-Roof of Burnet Elementary in the amount of \$545,335.00 (Five Hundred Forty Five Thousand, Three Hundred Thirty Five Dollars and no cents).

The recommended roofing contractor is a reputable company and is very active in the Houston area school and construction market. This contractor has performed past re-roofing projects in Katy Independent School District, Spring Independent School District, Lamar Consolidated Independent School District, Conroe Independent School District and currently has a project in Galveston Independent School District.
