### Definition of a Volunteer

The meaningful contribution of volunteers, including parents, guardians, and community members adds significant value to the District. Volunteer involvement enriches educational programs, improves student supervision and safety, and strengthens partnerships between schools and the community.

### Definition of a Volunteer

Volunteers are people who:

- Assists in school or District programs without compensation;
- Are excluded from the definition of “employee” under applicable state and federal statutes; and
- Are not employed by the District in the same or similar capacity for which they are volunteering.

### Volunteer Assistance

The Superintendent shall be responsible for developing and implementing procedures for utilizing volunteers. The procedures will facilitate effective communication with persons who volunteer. The final decision to accept or reject a volunteer applicant rests exclusively with the Superintendent.
