# **Professional Services contract with Henkles-McCoy**

January 9, 2007

### **SUMMARY:**

- This item requests approval of a professional services contract with Henkles-McCoy to engineer/project manage and create RFQ for bidders to extend DISD fiber to 1. To Elementary #18 from W.S. Ryan, 2. To Middle School #6 and Elementary #19 from Guyer HS, 3. Extend fiber from Providence Elementary to Naylor Road (joint project with Upper Trinity and Denton County)

#### PREVIOUS BOARD ACTION:

#### **BACKGROUND INFORMATION:**

- The DISD fiber network needs to expand its capability to the new school sites. This contract represents a professional service and project management service and was discovered by an RFSP sent on September 13, 2006. The vendors were slotted into a "point" system and Henkles-McCoy was selected. Henkles-McCoy was interviewed by Randy Stout, Ernie Stripling, Debbie Monschke, Kathy Arrington and Jack Farguson. The committee was in total agreement on the services being provided by Henkles-McCoy for the extension of fiber for DISD, Upper Trinity and Denton County. Henkles-McCoy will develop RFQ for the construction work after the engineering is complete.

- Costs will be borne by 2004 Bond for fiber extensions to new elementaries and middle school #6. Upper Trinity and Denton County will split costs of connections in the 380 east corridor.
