#### **NEW POSITIONS**

### 1 - Special Education Teacher - Harlem Middle School

Due to an increase in the number of students in our Life Skills/STP program, there is a need for two classrooms next year. There will be a total of 11 students with EE 03 placement and the class size limit according to Illinois Administrative Code is a maximum of 8 students per classroom.

#### 2 - CTE Teachers - Harlem High School

We have not yet fully implemented our college and career pathways, yet all of our CTE courses are at or very near their enrollment limits. We need to increase the number of available placements in each class in order for each student to progress through a pathway and for us to be ready to grow into any capital expansion. To facilitate this, we are asking that the School Board approve the creation of additional teaching positions in Manufacturing/Engineering and Family and Consumer Science.
