The motion failed.

The motion was made by Mr. Hill and seconded by Mrs. Evans to increase the hourly rate of the employees in Auxiliary Pay Grades 1, 2, 3, and 4, as well as CLPA Pay Grade 1, 2, and 3 by \$1.00. All remaining employees on Tiers 5-8 on Auxiliary and 4-8 on CLPA and all within the ADPR Scale will get a 2% of the midpoint.

All members voted in favor of the motion. The motion carried.
