#### 1. Introduction

On May 6, 2017, voters approved Collin College's \$600 million bond proposal to facilitate a long-range plan to accommodate the projected population growth in Collin County over the next two decades. The program consists of 4 new campuses and 2 new facilities.

On May 16, 2017, in a special session, the Board of Trustees granted the District President authority to enter and negotiate into contract with AECOM Technical Services, Inc. (AECOM) to provide Program Management Services to the Collin College 2017 Capital Improvement Program. On May 25, 2017, Collin College issued a Notice to Proceed to AECOM. As part of these services, AECOM will deliver a monthly report to provide status and progress of key aspects of the Program.

### 2. Executive Summary

The Program is progressing as planned with no major issues to report at this time.

#### **Completed and Pending Items**

- Drywall and MEP installations are on-going in the Academic Building, Trade Bar B, and Trade Bar C at the
  Technical Campus. Stair installations are complete in the Academic Building. Wall layout and metal stud
  installation is complete in Trade Bar B, Trade Bar C, and Trade Bar D. Site electrical and gas tie-ins are
  complete. Parking lot paving is complete. Curtainwall, polycarbonate and swiss pearl exterior panel
  installation is on-going. Elevator installation has begun in the Academic Building.
- MEP tie-in, drywall, glazing, millwork and masonry work is on-going in the buildings. Brown Street widening, intersection signalization, and bridge construction at the ephemeral stream is on-going at the Wylie Campus.
- Conley Group was issued a PO for the IT Center Construction Phase Building Envelope Services on February 4<sup>th</sup>
- Farnsworth was issued a PO for the IT Center Construction Phase Commissioning Services on February 5<sup>th</sup>
- RLK Engineering was issued a PO for the Frisco Campus Paving and Parking Design on February 21st
- AECOM received a proposal from RLK Engineering for the Frisco Campus Alumni Hall Fire Lane design on February 27<sup>th</sup>

#### Items of close attention

 Construction schedules are being closely monitored to ensure completion of the Phase 1 projects by Fall 2020

#### **Budget Summary**

- \$412,413,935 of the \$600,000,000 has been committed to-date in the form of contracts with various vendors. This represents 68.74% of the overall program budget committed.
- \$308,266,459 of the \$412,413,935 committed amount has been expended to-date. This represents 74.75% of the commitments to date and 51.38% of the program budget.






