As required by Section 6.03 of the Texas Property Tax Code, I have calculated the voting entitlement for those tax jurisdictions that are eligible to vote for the Board of Directors of the Ward County Appraisal District. The five directors that are elected will serve a two-year term beginning January 1, 2026. The number of votes calculated for each tax entity and the election procedures are as follows:

Before October 15, 2025 each jurisdiction may nominate up to five board members and notifies the Chief Appraiser of the nominee(s). I have enclosed a resolution for use in submitting the nominations.

Before October 30, 2025 the Chief Appraiser prepares a ballot listing the nominees and delivers a copy to the presiding officer of each of the governing bodies of the member jurisdictions.

Before December 15, 2025 each jurisdiction must cast its vote by written resolution and submit it to the Chief Appraiser.

Before December 31, 2025 the Chief Appraiser will tabulate the votes and the five nominees receiving the most votes will be declared elected to the Board of Directors. The Chief Appraiser will notify the nominees and the jurisdictions of the results.
