The Board of Trustees of United ISD met in a Special Called meeting on Tuesday, June 11, 2013, beginning at 7:04 PM in the United ISD – Boardroom, 201 Lindenwood Dr., Laredo, TX 78043.

A. Presentations by Finalists for Financial Advisor Services in Response to RFP-012-13

Judd Gilpin – We will have two presentations from two of the firms for the finalist for Financial Advisor Services.

Cordy Flores-Jackson - For you tonight we have the two finalists for Financial Services. Four firms submitted and the two finalists that the committee has for your tonight is Southwest and Estrada Hinojosa. The first

company that will present is Southwest they will have twenty minutes. Only the firm that is presented will be here and after they are done they will go outside and the other firm will come in and present. Once they are done with their presentations we will open it up for question and answers.

Southwest – Honorable President, Members of the Board, Mr. Santos thank you for having us here this evening. For the record my name is Victor Quiroga, Senior Vice President for Southwest Securities and with me is Duncan M. Morrow. We are out of the San Antonio office. It is an honor to be part of the short list here to present our Financial Advisor credentials to you. We have had history with the district and we will share that with you. Out of courtesy for your time and maintain the limitations given to us we have prepared a presentation here for you and passed as to you as well. This will cover different sections her to introduce the district to Southwest securities and particularly talk about our school finance experience and how we could help the district more forward if selected.

Mr. Quiroga went on and presented his presentation that will be available for your review at the United ISD Purchasing Department.

Estrada Hinojosa & Co. – Good Evening my name is Noe Hinojosa, with Estrada Hinojosa & Co. for the record. First of all I want to thank the Board for giving us the opportunity almost 10 years ago. We came here aboard on or about on September 2003. Now that things have passed since then we can't wait to share that experience with you. In essence if you open your booklets to page 3 you will find pretty much the theme we have assigned for this district.

Mr. Noe Hinojosa went on with his presentation which will be available for your review at the United ISD Purchasing Department.

In closing Mr. Noe Hinojosa addressed the Board – I think if anything we are encouraged to be tested from time to time and we welcome that. I can't commend that you for the fact that you are doing it far in advance. Here we are in June 11th conceivable you were to call a Bond referendum it would be some time in November. I think the earliest you can get your consultants lined up the better. I mentioned earlier about regulatory issues, I think transparency is a key issue. I think whoever you are going to be talking to about bond finances you want to have someone to be on your side. Basically reflect what you are trying to reflect to your client base to your kids and important to your tax payers. I think that what our firm is about, our firm is about working in teams in this case both Roberto Tijerina and myself will probably be leading that group dealing with you and the public. I think one of the things I commend you is that having a efficient staff working for you. I think have been challenged by them time and time again. It's not an accident that we would be able to pull out 6 refinances in a matter of 3 weeks. I

wouldn't say three weeks all the time inside of 6 weeks. I will give you an example – A client just south along the railroad shall remain nameless took him three and half months to operate. It was a financing close to 100 million dollars we thought we could get him 12M, but got the deal done for 9M. The key here is to be able to cease in the opportunities the minute they present themselves. I like to say in a way that I don't want to embarrass our client down the south, but it is very easy to lose big dollars. I know how hard you work for credibility and transparency. I think some of the things I learn back in the Election of 2003 and maybe the Election of 2007 as you go an embarking in the referendum sometime this fall is the fact that you want to engage the public as quickly as you can. But you also want to prudent as to the size of the Bond issue you are going to be calling whether you want to call it in a one proposition or a cafeteria style. The fact that you are doing it today in June you are going to be better off talking to the public and talking to other colleagues in your position across the city and the various ETA's you have in here so you can build up momentum as you go on in calling the Bond referendum I guess it is 60 days prior to the referendum you will have the momentum already built up. So with that I commend you. In closing, I have been in this business 26 years on my own as a banker, 22 years as an owner and I will tell you this, whoever you were to hire this firm is not for sale and we are not in any regulatory fines environment. We have been very responsible 21 + years. I think when you have three young men I think I'm part of that young men. You want to have a financial advisor that is prudent, disciplined and that is focused. If you do so choose to give us the opportunity again we will welcome the challenge and I promise that when you start in embarking in this referendum it will be my duty to be more closely affiliated with you to ensure that Mr. Santos and his staff is well represented. So with that we close and thank you for the opportunity to have us before you.

A Regular Meeting of the Board of Trustees of United ISD was held Wednesday, June 19, 2013, in the Bill Johnson Student Activity Complex, Fine Arts Building, 5208 Santa Claudia Lane, Laredo TX 78043. President, Judd Gilpin made an announcement calling the meeting of the United Independent School District to order at 6:08 p.m. The record showed that a quorum of Board members was present, that the meeting had been duly called, and that notice of the meeting had been posted in accordance with the Texas Open Meeting Act, Texas Government Code Chapter 551.
- III. Public Comments: Comments are limited to three minutes per speaker. The Board Parliamentarian will be the timekeeper and will inform the speaker when they have one (I) remaining minute. a member of the public, unless such response is a recitation of District policy or a statement of specific factual information. Furthermore, please refrain from mentioning any employee's name and any complaint about any employee's duties or responsibilities should be channeled through the appropriate grievance policy.

Edna Olmida Flores - Good Evening School Board member, Mr. Santos and all My Name is Edna Olmeda Flores and I am a TSTA/AR employee and tax payer of UISD. I would like to address item V-A on the agenda in reference to the proposed Bond. On behalf of Texas State Teachers Association, I am here today to express my/or concern on the proposed Bond Election. I understand we need more school to alleviate the overcrowdings in our classroom. I am concerned on how this may affect us as taxpayers.. For the past two years we teachers, employees and staff of UISD have not seen a salary increase in the past two years. On the contrary as was said on May 15, 2013 by Alejandra Lightner, YSYA Vice President we have been asked to be grateful we have a job and have been told to do more for less. Why can't the district do more with less? Mr. Juan Cruz stated the UISD has been very pro employee in absorbing the cost of the insurance increases in 2009 to present. May I remind Mr. Cruz that while the district absorbed the additional cost of the insurance increase, the district has not given us a salary increase for the past two years? So I ask, who has paid for that additional cost of the insurance increase that you so rightfully claim the district has absorbed. I challenge Mr. Cruz to calculate how much the district has saved with each employee's salary freeze. Not only to calculate how much money the district has saved by teachers who buy their own supplies, student incentives and so much more.

Judd Gilpin – We will have this item every month if you want to print it out to make it easier.

Edna Olmida Flores – I will close because there was something addressed to you specifically. In closing we do enjoy teaching and we grow fond of each and every student that walks thru our classroom. However, we do have children of our own, bills of our own and all the bills don't stand still for us either. Our rent goes up, gas prices go up and now our health insurance premiums and maybe our taxes will go up too. Yet, again for the past 2 years our salary has not gone up. Not only affecting our ability to pay our bills, especially if you are a single parent. It affects our retirement as well. Is this what Mr. Cruz refers to as being pro employee institution. Thank you.

Alejandra Lightner - Good afternoon Board members, Mr. Santos and all guest present. My name is Alejandra Diaz Lightner for the record. I am a taxpayer at United ISD. My question is what kind of economic impact the possible Bond will have on class size, working conditions and salaries. In the near future my salary will be affected by the higher cost of health insurance. My salary has been stagnant for the past 3 years. But, if this coming year salaries do go up I am sure the positive

impact will never reformate in my pockets. Although I am in favor of developments that impact education, I am weary on how my income will have to be stretched to afford the tax increase. So, I leave you with my previous question, how will this possible bond impact/benefit class size, salaries, working conditions, etc.?

Charlie San Miguel – Good Evening Honorable Chairman, Honorable Board, Charlie San Miguel for the record. Thank you for your time and I would like to begin in congratulating all the students and teachers that will be recognized here tonight. I am in complete support of the Bond Election. I think it is very important that our children have a level of a fair playing field when they are out there competing. I know that our community can compete with the best out there. We just need to be afforded the technology, the classrooms and the environment to learn. I taught about 20 years ago high school, so I have seen my ex students grow up, have families, compete and have careers. I have seen first had what a positive environment can have in our society, in our community. I have been to the school and seen where portable after portable is out there. It's not good; it's not a good learning environment that our children deserve. I am also concerned about security when we have all those portables out there. Now keeping in mind what these ladies just said I am totally and completely with them. I have seen in the last couple of years where the pay increase to the teacher and employees sis not keep up hardly with the increase and insurance costs. And, so I beg the board to please consider when you are looking at that increase that these teachers so deserve that you consider the increase of the insurance cost. That this pay increase not only go to the insurance company but go to these families.
