The Board of Education of Community Unit School District Number 304 met in a regular session on Monday, December 12, 2016, at 7:00 p.m. at the Coultrap Educational Services Center, 227 North Fourth Street, Geneva, Illinois

4. RECOGNITION, AWARDS, PRESENTATIONS, PUBLIC HEARING

4.1 All-Day Kindergarten Update

The Assistant Superintendent of Teaching and Learning presented to the Board an update on the all-day kindergarten program. Teachers have shared that the additional time they have gives students an opportunity to learn. They have seen an increase in reading levels in first grade students, as well as significant changes in writing, math, science, social studies and technology integration. Students in first and second grade have shown growth in social/emotional and developmental learning. MAP assessment data indicates that there has been a positive impact from all-day kindergarten.

5. SUPERINTENDENT'S REPORT (Policy 1210)

The Superintendent shared that the district is in the midst of winter activities with concerts and programs at all levels. This year is the first year that high school students will complete semester testing prior to winter break. Friday is the last day with students and teachers. School will resume on January 3, 2017. Thank you to the district staff who have been working hard to ensure that things run smoothly during the cold and snowy weather.

6.1 2016 Tax Levy Extension

The Assistant Superintendent of Business Services recommended to the Board the tax levy increase of 0.7% CPI. This is an estimated possible increase of \$1,814,901 that does not include Bond and Interest. The actual tax rate and levy amount will not be finalized by the County until March 2017.

There are currently no elementary students in this area, but this modification would include this area in the Western Avenue School boundaries. This is a proactive measure that will help to balance enrollment in the elementary schools and let perspective buyers with children know which school they would attend. This will come back to the Board for approval at a later meeting.
