Item I. Call to Order- Establishment of Quorum

The meeting was called to order at 6:33 p.m.

Item II. Pledge of Allegiance

Miss Zopelis, Student Representative, led the Board in the Pledge of Allegiance.

Item III. Secretary's Report- Approval of Minutes

Regular Meeting, 05/18/2020

Mr. Melnick made a motion, seconded by Mrs. Locke, that the Board approve the Secretary's Report for the regular meeting held on 05/18/2020, as presented. Ms. Bachiochi, Mr. Delano, Mrs. Locke, Ms. Lybarger, and Mr. Melnick voted for the motion, which carried.

A. <u>Curriculum Committee</u>- Mr. Melnick reported on the Curriculum Committee meeting, which was held on Monday, June 1, 2020. He reported on Distance Learning, Google Classroom, Seesaw, a new Robotics Course and a new Algebra II textbook. The Robotics Course and the Algebra II textbook will be presented to the full Board on Monday, July 13, 2020, for approval.

Item VII. Superintendent's Reports

A. Teacher of the Year 2021

Mr. Moccio announced that Stafford's Teacher of the Year for 2021 is Ms. Kim Jones, Elementary Teacher at Staffordville School. Mr. Moccio introduced Mr. Autieri, Director of Curriculum and Instruction, who facilitates the selection process.

Mr. Autieri outlined the Teacher of the Year selection process and shared portions of Ms. Jones's nominations, which highlighted her dedication and care for students. Item X. New Business

A. Disposition of Bid- Maintenance Agreement for Mechanical Systems

Mr. Moccio stated that bid specifications for a maintenance agreement for the districts mechanical systems, with the exception of the geo-thermal system, were advertised in the Journal Inquirer on April 24, 2020. Proposals were due by May 22, 2020, and bids were opened on May 26, 2020. The district received five (5) bid proposals, which were reviewed for completeness by Diane Peters, Business Manager, and Frank Bonavita, Director of Facilities.

The Board was provided with a memo from Mrs. Peters and Mr. Bonavita summarizing the results of the bids which ranged from \$17,203 to \$48,337. Significant difference in costs were present for two of the five bids. Both Mrs. Peters and Mr. Bonavita recommend the acceptance of the bid for maintenance of the mechanical systems from EMCOR Services, at a cost of \$27,124 per year. The bid is a one-year commitment with pricing for optional years should the district continue with the company in the future.

Mrs. Peters and Mr. Bonavita reviewed the bid process and were available to answer any questions.

Mr. Delano made a motion, seconded by Mr. Melnick, that the Board of Education award the maintenance agreement for mechanical systems to EMCOR Services for the 2020-2021 school year. Ms. Bachiochi, Mr. Delano, Mrs. Locke, Ms. Lybarger, and Mr. Melnick voted for the motion, which carried.

Mrs. Locke made a motion, seconded by Ms. Lybarger, to move items XI.A.- Interview Candidate for the Position of Interim Director of Pupil Services (Executive Session Anticipated) and XI.B.- Review and Possible Approval of Non-Affiliated Salary Increases (Executive Session Anticipated), into executive session. Ms. Bachiochi, Mr. Delano, Mrs. Locke, Ms. Lybarger, and Mr. Melnick voted for the motion, which carried.
