**III.1. Blytheville School District Level 5 - Intensive Support Hearing**

The Blytheville School District Level 5 - Intensive Support Hearing item was presented by Ms. Stacy Smith, Deputy Commissioner. Also present was Mr. Daniel Shults, ADE Litigation Attorney. Present on behalf of Blytheville School District were Ms. Jennifer Blankenship, Interim Superintendent; Mr. Desmond Hammett, School Board President; Mr. Robert L. The Division of Elementary and Secondary Education recommended that the State Board of Education classify the Blytheville School District as in need of Level 5 - Intensive Support in accordance with Ark. Code Ann. § 6-15-2916. The Blytheville School District appealed this classification and requested a hearing.

A motion to classify Blytheville School District as in Level 5-Intensive Support was made by Dr. Gary Arnold, seconded by Ms. Adrienne Woods. The motion unanimously passed. Roll call was taken.
