<p>Has three groups for fee purposes</p> <ul style="list-style-type: none"> <li>• <b><u>Group 1:</u></b> School-related nonprofit and endorsed organizations such as school-sponsored clubs, PTAs, Booster Clubs, Scouts BSA, and nonprofit organizations with prior agreements. Personnel fees apply as appropriate.</li> <li>• <b><u>Group 2:</u></b> Nonprofit organizations including youth athletic groups primarily serving Manor ISD students (90% or greater), civic organizations, homeowners associations, religious organizations within the District, community college offerings, and election-related uses. Facility fees may be waived during school hours and certain times on school days, with fees and insurance requirements applying at other times.</li> <li>• <b><u>Group 3:</u></b> For-profit organizations, including companies, individuals, and youth athletic groups not primarily</li> </ul>	<p>Has two groups for fee purposes:</p> <p><b>Group 1:</b> School-Related Nonprofit and Endorsed Organizations, School-sponsored clubs and activities; School related groups: Such as PTA, Booster Clubs, Educational Foundations, Service Clubs, Scouts BSA</p> <p>For public meetings sponsored by state or local governmental agencies;</p> <p>Civic organizations, homeowners associations, religious organizations within the District, community college offerings, and election-related uses. Facility fees may be waived during school hours and certain times on school days, with fees and insurance requirements applying at other times.</p> <p><b>Group 2:</b> All Other Groups</p> <p>-----</p> <p>-Group 1 will have no or at cost fees</p> <p>-Group 2 will have full rates charged above</p>
