Action Items

Consider Approval of 2022-2023 Salary Schedules – District administrators have been working on an updated salary schedule for teachers, administrators, paraprofessionals, and trades for the upcoming school year 2022-2023. Salary schedules are necessary to calculate the 2022-2023 budget, and it has been Smithville I.S.D.'s practice to inform staff as early as possible of any changes to the salary schedules. Salaries have to be set each year and have a major impact on the district budget, which must be adopted no later than August 31, 2022. Josh Magden moved to approve the salary schedule as presented. Michael Hancock seconded and the motion carried 7-0.

<u>Approval of Expenditure in Excess of \$50,000</u> – The purpose of this agenda item was to authorize the purchase of needed technology upgrades and high school parking lot improvements. The expenditures would include upgrades to multiple desktop computers, adding chromebooks throughout the district, and district technology upgrades at the high school campus,

as well as maintenance improvements on the high school parking lot. The cost of these upgrades is \$171,600 and the intent is to utilize funds that were received by Smithville ISD for the Chapter 313 Supplemental Payment, anticipated excess tax collections and ESSER III ARP funds. Alan Hemphill moved to approve the expenditures as presented. Candice Parsons seconded and the motion carried 7-0.

<u>Review and Approve 2022-2023 Student Dress Code</u> – The student dress code is annually reviewed by the administration, campus site-based committees, and the district site-based committee. Candice Parsons moved to approve the 2022-2023 student dress code as presented. Nancy Towry seconded and the motion passed 7-0.

Consider Custodial Contract Renewal – Our current agreement with IQS, Inc became effective June 15, 2019. The agreement was for one year with four possible renewals each year thereafter by amendment upon approval of the Board of Trustees. This request is the ^{3rd} renewal request for this contract. Any renewal shall be an amount not to exceed the CPI rate of 2%, which amounts to an increase of \$11,843 on our current fees. Per the terms of the custodial service agreement, it is the recommendation of administrative staff that the Board of Trustees renew the custodial contract with IQS, Inc for an additional year. Alan Hemphill moved to renew the custodial contract with IQS, Inc. as presented. Chris Hinnant seconded and the motion carried 7-0.

Consider Approval to Amend Signatures on Bank Depository - As a result of the reorganization of the Board of Trustees, there was a change in officers. The Board President and the Board Secretary must be authorized to sign on the District accounts at First National Bank, the District's depository. Alan Hemphill moved that President Grant Gutierrez remain as a signator on the account at First National Bank, and that Secretary Candice Parsons replace Nancy Towry. Josh Magden seconded and the vote passed 7-0.

Consider Appointment of Delegate to Represent Smithville ISD at the 2022 TASA/TASB Convention Delegate Assembly – The TASB Delegate Assembly is a crucial component of the Association's governance structure. Each active member (school board) of the Association is entitled to have a delegate and an alternate attend the Assembly and cast our district's vote on action items coming before the Assembly. The TASA/TASB Convention this year is September 22-25, 2022 and will be held at the Henry B. Gonzalez Convention Center in San Antonio, Texas. The 2022 Delegate Assembly will meet on Saturday, September 24th. Grant Gutierrez moved to appoint Candice Parsons as the delegate and Nancy Towry as the alternate. Alan Hemphill seconded the motion and it passed 7-0.

<u>Distribution of Board Self-Evaluation Materials</u> – The Board President requested that a completed Board Self-Assessment Instrument be returned by each member of the Board for tabulation on the week prior to the regular June meeting.

Personnel

<u>Resignations of Certified Personnel</u> – The Superintendent informed the Board of the resignations of Stephanie Brant, Haley Nunn, and Sarah Carder-Gutierrez. No action was required.

Employment of Certified Personnel – According to Board Policy DC [Local], the Superintendent has the authority to make recommendations to the Board regarding the selection of all personnel. The Superintendent recommends employment of the following employees: Gail Deeley as a teacher at Smithville Elementary, Gary Krause as a teacher/coach at Smithville Junior High School, Kylee Friend as a teacher at Smithville Junior High, Claude Bassett as a teacher/coach at Smithville High School, Justin Benvegnu and Michelle Broadway as teachers at Smithville High School, Lee Hartsell as assistant principal at Smithville High School, Erin Seale as school nurse and Lindsey Saunders as District Communications Officer. Candice Parsons moved to approve employment as presented. Michael Hancock seconded and the motion carried 7-0.

The Board President adjourned the meeting at 8:52 pm.
