PERSONALLY IDENTIFIABLE INFORMATION **

Personally identifiable information includes, but is not limited to:

- 1. Student's name, if excluded from directory information, as requested by the student/parent in writing;
- 2. Name of the student's parent(s) or other family member;
- 3. Address of the student or student's family, if excluded from directory information, as requested by the student/parent in writing;
- 4. Personal identifier such as the student's social security number or secure student ID number (SSID);
- 5. A list of personal characteristics that would make the student's identity easily traceable;
- 6. Other information that would make the student's identity easily traceable.

Prior Consent to Release

Personally identifiable information **will shall** not be released without prior signed and dated consent of the parent, student 18 years or older or emancipated.

Notice of and/or request for release of personally identifiable information shall specify the records to be disclosed, the purpose of disclosure and the identification of person(s) to whom the disclosure is to be made. Upon request of the parent or eligible student, MESD **will shall** provide a copy of the disclosed record.

Exceptions to Prior Consent

MESD may disclose personally identifiable information without prior consent under the following conditions:

- 1. To personnel within MESD who have legitimate educational interests;
- 2. To personnel of an education service district or state regional program where the student is enrolled or is receiving services;
- 3. To personnel of another school, another district, **state regional program** or institution of post-secondary education where the student seeks or intends to enroll;
- 4. To personnel connected with an audit or evaluation of federal or state education programs or the enforcement of or compliance with federal or state legal requirements of MESD;

- 5. To appropriate parties determining a financial aid request for the student;
- 6. To personnel conducting studies for or on behalf of MESD;
- 7. To personnel in accrediting organizations fulfilling accrediting functions;
- 8. To comply with a judicial order or lawfully issued subpoena;
- 9. For health or safety emergency;
- 10. By request of a parent of a student who is not 18 years of age;
- **11.** By request of a student who is 18 or older or emancipated;
- 12. Because information has been identified as "directory information;"-
- 13. To the courts when legal action is initiated;
- 14. To state and local juvenile justice agencies;

END OF POLICY

**As used in this policy, the term parent includes legal guardian or person in a parental relationship. The status and duties of a legal guardian are defined in ORS 125.005 (4) and 125.300 – 125.325. The determination of whether an individual is acting in a parental relationship, for purposes of determining residency, depends on the evaluation of the factors listed in ORS 419B.373. The determination for other purposes depends on evaluation of those factors and a power of attorney executed pursuant to ORS 109.056.
