BACKGROUND AND SIGNIFICANT ISSUES: On April 10, 2012 the Region One Education Service Center Board of Directors met to review and approve the recommendation of the Web and Mobile Device Application Development Service Qualification 12-02-15, effective April 18, 2012 through April 30, 2014, with three (3) additional one (1) year extension options. On April 22, 2014 the Region One ESC Board of Directors met to review and approve the first of three (3) one-year extension options effective May 1, 2014 through April 30, 2015 and on February 24, 2015 the Region One ESC Board of Directors met to review and approve the second of three (3) one-year extension options effective May 1, 2015 through April 30, 2016. This proposal allows the Region One ESC the opportunity to purchase rich data driven web applications, mobile device applications, and the integration of other technologies during application development. The current awarded vendors were offered, and all accepted, the opportunity to extend their contract for a final one (1) year period; the term of this contract extension is effective May 1, 2016 through April 30, 2017.

RELATED GOAL(S): To assist cooperative members in Region One and other school districts, charter schools, and governmental entities throughout the State to operate more efficiently and economically (TEC §8.002).

COST AND FUNDING SOURCES: Cost will be negotiated based on the application desired. Each department, program and/or cooperative member will bear the related costs for the application development services requested.

EXECUTIVE DIRECTOR'S RECOMMENDATION: Recommend approval of the Web and Mobile Device Application Development Service Qualification 12-02-15, Extension, to the following vendors: *Compunnel Software Group – Plainsboro, NJ, Copper Mobile – Dallas, TX, Mobile K-16 LLC – Port Isabel, TX.*
