### ADMINISTRATIVE REPORTS

### Principals -

The Principals were all in attendance. Mrs. Wysong highlighted a great start to the year. Washington and Lincoln began training to make government interesting to little people including the discussions of community, responsiblility and kindness. Mrs. Millburg discussed the supplemental income going on for the school including various programs such as Book Fair, Box Tops and County Market Max Dollars. A large emphasis on Crisis Management has been taking place so that the appropriate measures are available and taken in the event of evacuation. Teachers are getting ready for parent teacher conferences as well as forming committees within the school. Mrs. Ellis reported on the Open House, the classes discussed the importance of September 11th throughout the school, the PBIS trip to Ramsey Lake was successful, and the ICE BOX fundraiser was a hit. The teachers are preparing for student led conferences to be held the first week of October. Mrs. Adam discussed the new school sign should be up soon. She talked about a good amount of conversation on September 11th in her building as well. She also shared a form letter with her teachers to reach out and invite parents as well as students to come to parent teacher conferences. Math teachers will be meeting with the ROE office to address those deficit areas. The focus for PBIS efforts is attendance and there are competitions being held between classes with prizes to reward good attendance. The ROE Regional Institute is being set up and everything is lined up in the building to make it a smooth event. The discussion of a lanyard system was discussed, but would be looked into further with other conference schools.

## **Cirriculum and Instruction**
