Approval of Guaranteed Maximum Price for the Construction of Comprehensive High School #4

SUMMARY:

This item requests approval of the Guaranteed Maximum Price submitted by Balfour Beatty for the construction of Comprehensive High School #4.

BOARD GOAL:

Vision ... In pursuit of excellence, the district will: remain committed to providing equitable and outstanding opportunities for every student on every campus

PREVIOUS BOARD ACTION:

On March 25, 2014 the Board approved an Order Authorizing Issuance of bonds from the 2013 Bond Program for construction of the high school.

BACKGROUND INFORMATION:

The 2013 Bond Authorization included funding for the construction of Comprehensive High School #4. Workshop Sessions were held on January 21, 2014 and May 13, 2014 with the Board of Trustees to discuss the plans for construction of the new high school.

SIGNIFICANT ISSUES:

The guaranteed maximum price (GMP) submitted by Balfour Beatty is \$116,064,157. In addition to the GMP the District considered additional alternates.
