Would like to see the budget committee needs to make sure that as enrollment goes back up that we do not see higher student to teacher ratios. Just in case we don't get the SIG grant/collaborative grant

Biggest class is 25 at FCS – with instructional assistance (teacher to student ratio)

K-5 is projected to be 24 (this year it is 22)

If the numbers go up, then we may need to add another teacher.

COMMENTS:

- Add back, so that we have not lowered the student to teacher ratio. If the school needs more FTE for staff, they get it (The district keeps a contingency to help).
- Focusing on K-3
- Adding to enhance the extra-curricular (art/sports/clubs)
- Security protocol for not having the SRO how are we planning and keeping the students safe.
- Would like to have both a SRO and a counselor, but the students have not had a counselor for several years and there is a need for academic support
- PERS is 23% to 28% .25 cents on the dollar insurance has been capped \$1190
- Would like to get more IAs into the classroom.
- The schools are well maintained, not anticipating any issues
- 3.5/4 positions for the day shift at the police station questions about the SRO and help without the SRO
- If we need an officer we would need to call dispatch (YCOM)
- Steve: roll-up costs/ 1 elementary position & 3 IAs/ SRO priority list
- Kari: same as Steve's
