### 061724 (7c) Preliminary FY25 Budget Presentation

Mr. Eagan reviewed the FY2025 budget process and timeline. Mr. Eagan stated that the tentative budget will be presented to the Board of Education on August 6, 2024, and placed on public display for at least 30 days at Central Office.

Mr. Eagan reviewed the revenue highlights, stating that the total budgeted revenue in the Operating Funds is estimated to be \$57,519,184. Mr. Eagan also reviewed the expense highlights, stating that the total budgeted expenses in the Operating Funds are estimated to be \$58,249,829.
