Ramiro Veliz, III called the meeting to order at 6:02 p.m.

#### IV. Public Comments:

Comments are limited to three minutes per speaker, except that non-English speakers requiring a translator are limited to six minutes. The presiding Board officer may modify or waive these time limits as appropriate. Public comment shall not be used for personal attacks by the speaker against District employees or students. Speakers who engage in personal attacks or use insulting, profane, threatening or abusive language during any Board meeting shall be ruled out of

order by the presiding Board officer and may be escorted from the Board meeting room by District peace officers or security staff. Any concerns or complaints regarding individual District employees, students, or parents must be resolved via the appropriate complaint process, as stated in Board Policy BED (Local). Pursuant to section 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public regarding an item that is not listed on this agenda, unless such response is a recitation of District policy or a statement of specific factual information.

Memo Castro – thanked the board for their service. He spoke regarding Muller acquisition of land. Mr. Castro provided the board members with a letter from 1996 which is when the school was built. He stated his concern is why the district built a school that did not meet certain standards. It was built without a public road access and asked where were the legal attorneys at that time to prevent this from happening. Mr. Castro added that the problem lies on the district's failure and the city's failure to stand up and do the right thing. Mr. Castro asked what guarantees are there to prevent what is happening to the school which is surrounded by manufacturing and why was the zoning not changed to address this issue. He asked the board to do the right thing, to find a better way by buying those acres in front of the school and make something more appropriate for future growth.

Robert Ortiz – Principal at Juarez Lincoln Elementary School, congratulated the board and thanked them for their service to the district on behalf of the 30 Elementary School principals, the Elementary Curriculum and Instruction Department and the more than 19,000 students they serve. He thanked them for their leadership and their support throughout the year and for everything that they do for the children of United I.S.D.

Gilbert Moreno – Principal at Trautmann Middle School, congratulated the board and thanked them for their service to the district on behalf of the 12 middle school principals and executive director, Ms. Cynthia Ramirez. He thanked the board for their continuous support of teachers, students and staff and for being strong and resilient and meeting the challenges of UISD.

Jessica Salazar – Principal at United High School, congratulated the board and thanked them for their incredible dedication and hard work. She recognized their selfless commitment as they significantly contribute to the success of our schools and again thanked them for their service and leadership and loyalty on behalf of the faculty, staff and students at Alexander, Johnson, United and United South High Schools and Ms. Melissa Cruz.

Edna Olmedo – Teacher – addressed the board regarding teacher and staff compensation. Pursuant to section 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public regarding an item that is not listed on this agenda, unless such response is a recitation of District policy or a statement of specific factual information.

Petra M. Castro: Ms. Castro, board of directors for La Bota Ranch Home Owners Association. She speaks in representation of the families of La Bota Ranch. Ms. Castro expresses her concerns about the subdivisions ongoing threats of air pollution (Ethylene Oxide) and commercial traffic. She is a cancer survivor of Non-Hodgkin's Lymphoma and says that she believes it is a direct result of the Ethylene Oxide in the air, and that they need to protect their neighborhoods and school, against the developers and their greed of

self-interest. Ms, Castro said she does not agree with the purchase of the property next to Muller Elementary. "This will not solve the problem", she stated. She is particularly against the construction of the Warehouse directly across the street from the school. "In the end this only seems to be a political payoff", said Ms. Castro.

Clarissa Fraga: Speaking regarding safety and security. Ms. Fraga addresses the board and community to state her opinion that many safety and security issues must be addressed. Ms. Fraga makes the claim that the district has charged students with felonies over simple assumptions of being under the influence. She continues to provide the board with scenarios of alleged reports with wrongful arrests.

Edna Olmeda on the Refer-A-Friend staff incentive. Ms. Olmeda suggests to the board that if administration rather provide more/better benefits to staff, perhaps there would be no need to provide incentives. She says that this is just another instance of lack of transparency. "Refer-A-Friend, who would want to do that to a friend?", expressed Ms. Olmeda. She says that she would not refer a friend to a job where they are underpaid, overworked and disrespected. Ms. Olmeda points out that the district has too many positions and that she has consistently spoken at public comments to ask for raises.

Valentin Ruiz on Safety and Security. Mr. Ruiz states that district administration has, in his opinion, wrongfully arrested students. Furthermore, that students that confessed, did not get arrested. "It was a police coverup", he said. Mr. Ruiz also suggests that LISD and UISD police officers must carry a "stop-the-bleed" kit and that not doing so is a waste of taxpayer money. He adds that the teachers and staff should be rewarded, due to the increase in cost of living, but that instead their efforts are being ignored. He states that employees are suffering financially. "Why did you run for board, if you continue to ignore our cries as taxpayers."

Jose Ovando on UISD v. Gonzalez: Mr. Ovando questions the board on whether or not they will take action on conversations of witness testimony referring to the independent hearing examiners report. He brings up instances of the board's testimony and mimics their response. Mr. Ovando is of the opinion that the Texas Education Agency (TEA) needs to take over the district.

Bella Dianelly on UISD v. Gonzalez: Ms. Dianelly comments that she was present in at least one of the days of the investigation and that much of the hearing was omitted. She questions the board why that was so and makes her assumptions of nepotism and unfairness. She states that on page 15 of the report Dr. Linda Garza was appointed as "New Lead Psychologist", a position in which she was the sole applicant. Furthermore, Dr. Garza created the position (making reference to the job description she drafted herself). Ms. Dianelly asks why the board did not question that only one person applied, having so many suitable candidates in the community. She quotes Mr. Mike Garza's response that "this was not normal practice", and questions the board if they will reprimand Mr. Garza for not bringing this to their attention. Ms. Dianelly expresses her disagreement in the manner this

position was handled, and makes claims of corruption, unfairness and wages. "You all are the watchdogs" she said addressing the board.

Aliza Oliveros states for the record that the report was not a transcript and that the board is not hiding anything from the public. "That is just the Hearing Examiners Report" so it will not include everything that happened during the hearing.

Legal counsel chimes in to confer with Mrs. Oliveros. Jaime Garcia states that the recommendation is not drafted by the district, it is drafted by the Texas Education Agency (TEA) appointed Independent Hearing Examiner, who is independent.

Victor Vazquez also regarding UISD v. Gonzalez. Mr. Vazquez says that he too has many questions. He wants to know who requested the emails between Linda Garza and Gonzalez. Mr. Vazquez claims that there were many contradictions amongst them and that the Human Resource department was covering for Gonzalez in both cases. He states that the attorneys for the 2011 case, found "no merit", and that the law firm of Thomspon and Horton trashed the department (HR dept.). Mr. Vazquez asks that legal counsel are the ones that draft the letters (to then David Garcia). "Yes, or no?", he asks.

Guillermo "Memo" Castro speaking on the property next to Muller Elementary. Mr. Castro says he was at a graduation event and applauds the teachers. Mr. Castro asks the board to table the item on the possible purchase of the property next to the school. Instead he suggests the board have a discussion with parents on this matter. He says that teachers need help. "We need to invest money on their salaries, because a teacher goes a long way, we are a product of that"!

Leticia Juarez commenting on Safety concerns. Ms. Juarez begins by commending law enforcement personnel and has a deep admiration, being that her husband and two brother-in-laws were also part of law enforcement. Ms, Juarez points out safety concerns such as the locked door policy, having only one police officer stationed at each school regardless of population, hours of active shooter training for police officers, among others. She comments that she addressed Mr. Mike Garza (via email) and she was directed to request open records.

Mr. Mike Garza clarifies that the email request included a purchase order document and this is the reason why it went through the open records request process.

David Perez, president of the United Classroom Teachers Association, 25 year teacher, parent and taxpayer. Mr. Perez comments that should the board decide to terminate Mr. David Gonzalez's contract, then the board should immediately begin the process of selecting a new superintendent. "This is essential" he says, to have a new leader in place before the start of the 2024-2025 school year. He suggests that the board must select a leader with strength in academics and must thoroughly vet prospects and allow the public to be able to interview the finalists.
