Wanted to let you know that we had a productive meeting with Prologis last week. There were some clarifying things we learned – that I think y'all would be interested to learn as well.

For example, there is an entrance/exit off of Sandy as well as 122nd – and the buffer area is much larger than what was shared in the meeting we had with you and the other members of the school board.

In other words, I think we need to facilitate some basic information sharing – and then go from there.

I asked the company in the meeting if they could pull together a presentation with renderings to share with you two, specifically. I think they would be open to that. I am going to follow up with them in writing to get that ball moving and then I'll be back in touch.

Thanks for the update. It is encouraging to hear that ProLogis is open to communicating with the district. I am curious about hours of operation, diesel emissions / types of trucks, and the number of jobs they anticipate will be available. We knew about the Sandy exit/entrance...it's why we are so concerned for residents who live in the apartments adjacent and have to cross the Sandy entrance to get to school. (If you visit the site in person, it might be clearer).

Any update on the legal research into the moratorium request?

Also, I keep hearing from community members and students who have heard in the news about K-12 STEM opportunities through the CHIPS Act. Any word from BPS on how the City plans to support that? Right now our students have to travel downtown / to the west side for technical education, and that's a barrier for many. I'm hopeful there's a way to find a "win" for our students and community, even if it takes a while. I've told folks I would ask and see what's possible.
