

**MINUTES** of a regular meeting of the Board of Education  
of District Number 304, Kane County, Illinois, held at the  
Williamsburg Elementary School, 1812 Williamsburg Ave., Geneva, Illinois,  
in said School District at 7:00 o'clock P.M., on the 10th day of March, 2014.

The meeting was called to order by the President, and upon the roll being called, Mark Grosso the President, and the following members of the Board of Education were physically present at said location: \_\_\_\_\_

The President announced that the Board of Education would next consider the adoption of a resolution providing for the partial abatement of taxes heretofore levied for years 2014 and 2015 for the purpose of paying principal and interest on the School District's General Obligation School Bonds, Series 2004A.

Whereupon Member \_\_\_\_\_ presented and the Secretary read in full a resolution as follows:

**RESOLUTION** providing for the partial abatement of taxes heretofore levied  
for the years 2014 and 2015 for the payment of principal and interest on the General  
Obligation School Bonds, Series 2004A, of Community Unit School District  
Number 304, Kane County, Illinois.

WHEREAS, on the 22nd day of November, 2004, the Board of Education (the  
“School Board”) of Community Unit School District Number 304, Kane County, Illinois (the  
“District”), adopted a resolution providing for the issue of not to exceed \$41,185,489 General  
Obligation School Bonds, Series 2004A (the “2004A Bonds”) of the District and for the levy of a  
direct annual tax sufficient to pay the principal and interest on the 2004A Bonds (the “2004A  
Bond Resolution”); and

WHEREAS, on the 23rd day of November, 2004, a duly certified copy of the  
2004A Bond Resolution was filed in the office of the County Clerk of Kane County, Illinois (the  
“County Clerk”); and

WHEREAS, the 2004A Bond Resolution called for the levy of a direct tax upon  
all the taxable property within the District sufficient to produce the sum of \$6,000,000 for tax  
year 2012 for the payment of principal and interest on the 2004A Bonds up to and including  
January 1, 2014; \$7,000,000 for tax year 2013 for the payment of principal and interest on the  
2004A Bonds up to and including January 1, 2015; \$10,000,000 for tax year 2014 for the  
payment of principal and interest on the 2004A Bonds up to and including January 1, 2016; and  
\$12,000,000 for tax year 2015 for the payment of principal and interest on the 2004A Bonds up  
to and including January 1, 2017; and

WHEREAS, on the 2nd day of December, 2004, responsive to authority contained  
in the 2004A Bond Resolution, a contract for the purchase of \$41,186,000 General Obligation  
School Bonds, Series 2004A (the “Bonds”) was awarded by then-President of the Board and

then-Business Manager, as the "Designated Representatives" of the District under the 2004A Bond Resolution; and

WHEREAS, on the 20th day of December, 2004, a duly certified copy of the Direction for Abatement of Taxes was filed in the office of the County Clerk of Kane County, Illinois (the "County Clerk") which, in accordance with the provisions of the 2004A Bond Resolution, directed the abatement of the taxes levied in the 2004A Bond Resolution; and

WHEREAS, the Direction for Abatement of Taxes filed with the County Clerk ordered and directed the County Clerk to abate from the taxes levied in the 2004A Bond Resolution as follows: 1) for tax year 2012, the amount of \$1,279,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2012 in the amount of \$4,720,750; 2) for tax year 2013, the amount of \$1,539,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2013 in the amount of \$5,460,750; 3) for tax year 2014, the amount of \$1,324,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2014 in the amount of \$8,675,750; and 4) and for tax year 2015, the amount of \$1,824,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2015 in the amount of \$10,175,750; and

WHEREAS, on the 25th day of June, 2007, the Board of Education the School Board adopted a resolution providing for the issue of not to exceed \$100,000,000 General Obligation School Bonds, Series 2007A, of the District (the "2007A Bond Resolution"); and

WHEREAS, on the 26th day of June, 2007, a duly certified copy of the 2007A Bond Resolution was filed in the office of the County Clerk of Kane County, Illinois (the "County Clerk"); and

WHEREAS, on the 10th day of July, 2007, responsive to authority contained in the 2007A Bond Resolution, a contract for the purchase of \$85,820,000 General Obligation School Bonds, Series 2007A (the "2007A Bonds") was awarded by the then-President of the Board and the then-Assistant Superintendent for Business of the District, as the "Designated Representatives" of the District under the 2007A Bond Resolution; and

WHEREAS, on the 26th day of July, 2007, responsive to authority contained in the 2007A Bond Resolution, a duly certified copy of the Certificate of Reduction of Taxes Heretofore Levied for the Payment of Bonds was filed in the office of the County Clerk; and

WHEREAS, the Certificate of Reduction of Taxes filed with the County Clerk on the 26th day of July, 2007, in accordance with the provisions of the 2007A Resolution, ordered and directed the County Clerk to further reduce the taxes levied in the 2004A Bond Resolution as follows: 1) for tax year 2012, the amount of \$290,500, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2012 in the amount of \$4,430,250; 2) for tax year 2013, the amount of \$290,500, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2013 in the amount of \$5,170,250; 3) for tax year 2014, the amount of \$290,500, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2014 in the amount of \$8,385,250; and 4) for tax year 2015, the amount of \$3,165,500, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2015 in the amount of \$7,010,250; and

WHEREAS, on the 12th day of September, 2011, the Board of Education adopted a resolution providing for the issue of not to exceed \$15,500,000 General Obligation Refunding School Bonds of the District (the "Refunding Bond Resolution"); and

WHEREAS, on the 29th day of November, 2011, a duly certified copy of the Refunding Bond Resolution was filed in the office of the County Clerk of Kane County, Illinois (the "County Clerk"); and

WHEREAS, on the 9th day of November, 2011, responsive to authority contained in the Refunding Bond Resolution, a contract for the purchase of \$8,755,000 General Obligation School Bonds, Series 2011 (the "2011 Bonds") was awarded by the then-President of the Board and the Superintendent of the District, as the "Designated Representatives" of the District under the Refunding Bond Resolution; and

WHEREAS, on the 29th day of November, 2011, responsive to authority contained in the Refunding Bond Resolution, a duly certified copy of the Certificate of Reduction of Taxes Heretofore Levied for the Payment of Bonds was filed in the office of the County Clerk; and

WHEREAS, the Certificate of Reduction of Taxes filed with the County Clerk on the 29<sup>th</sup> day of November, 2011, in accordance with the provisions of the Refunding Bond Resolution, ordered and directed the County Clerk to further reduce the taxes levied in the 2004A Bond Resolution as follows: 1) for tax year 2012, the amount of \$435,000, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2012 in the amount of \$3,995,250; 2) for tax year 2013, the amount of \$435,000, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2013 in the amount of \$4,735,250; 3) for tax year 2014, the amount of \$435,000, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2014 in the amount of \$7,950,250; and 4) for tax year 2015, the amount of \$435,000, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2015 in the amount of \$6,575,250; and

WHEREAS, on the 10th day of January, 2012, also responsive to authority contained in the Refunding Bond Resolution, a contract for the purchase of \$4,165,000 General Obligation Refunding School Bonds, Series 2012 (the "2012 Bonds") was awarded by the then-President of the Board and the Superintendent of the District, as the "Designated Representatives" of the District under the Refunding Bond Resolution; and

WHEREAS, on the 24th day of January, 2012, also responsive to authority contained in the Refunding Bond Resolution, a duly certified copy of the Certificate of Reduction of Taxes Heretofore Levied for the Payment of Bonds was also filed in the office of the County Clerk; and

WHEREAS, the Certificate of Reduction of Taxes filed with the County Clerk on the 24th day of January, 2012, in accordance with the provisions of the Refunding Bond Resolution, ordered and directed the County Clerk to further reduce the taxes levied in the 2004A Bond Resolution as follows: 1) for tax year 2012, the amount of \$205,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2012 in the amount of \$3,790,000; 2) for tax year 2013, the amount of \$205,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2013 in the amount of \$4,530,000; 3) for tax year 2014, the amount of \$205,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2014 in the amount of \$7,745,000; and 4) for tax year 2015, the amount of \$1,570,250, and to extend the remainder of such taxes so levied for the 2004A Bonds in tax year 2015 in the amount of \$5,005,000; and

WHEREAS, on the 11th day of February, 2013, the Board of Education adopted a resolution providing for the partial abatement of taxes heretofore levied for the years 2012, 2013 and 2014 in the total amount of \$4,990,000 for the payment of principal and interest on the

General Obligation School Bonds, Series 2004A directing the County Clerk to reduce the amount of taxes levied and to be extended for the District's 2004A Bonds for the year 2012 by the amount of \$298,136 to the amount of \$3,491,864; for the year 2013 by the amount of \$3,230,973 to the amount of \$1,299,027; and for the year 2014 by the amount of \$1,460,891 to the amount of \$6,284,109; and

WHEREAS, the District now has on hand in its Debt Service fund the amount of \$5,931,638 which is available to pay a portion of the aforesaid principal and interest on the 2004A Bonds due on or before January 1, 2017; and

WHEREAS, the Board finds and determines that it is in the best interests of the District that the \$5,931,638 on hand and available in the Debt Service fund of the District be used to pay a portion of the aforesaid principal and interest on the 2004A Bonds due on or before January 1, 2017; and

WHEREAS, as a direct result thereof, it is in the best interests of the District that part, but not all, of the 2014 and 2015 taxes heretofore levied for the payment of principal and interest on the 2004A Bonds be abated.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Community Unit School District Number 304, Kane County, Illinois, as follows:

SECTION ONE. That the School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this resolution by this reference.

SECTION TWO: That the \$5,931,638 on hand and available in the Debt Service fund of the District be used to pay a portion of the aforesaid principal and interest on the 2004A Bonds due on or before January 1, 2017.

SECTION THREE: That part, but not all, of the taxes heretofore levied for the years 2014 and 2015 for the payment of principal and interest on the 2004A Bonds are hereby abated, as follows:

and the County Clerk of the County of Kane is hereby directed to reduce the amount of taxes levied and to be extended for the District's 2004A Bonds for the year 2014 by the amount of \$2,532,392 to the amount of \$3,751,717; and for the year 2015 by the amount of \$3,399,246 to the amount of \$1,605,754.

SECTION FOUR: That this Resolution shall affect taxes only for the years 2014 and 2015 and only to the extent that they relate to the 2004A Bonds.

SECTION FIVE: That the President and Secretary of the Board are hereby authorized and directed to execute a true and correct copy of this Resolution and the Administration of the District is hereby authorized and directed to file duly-certified copies of this Resolution in the office of the County Clerk of the County of Kane, Illinois.

SECTION SIX: That this Resolution shall be in full force and effect forthwith upon its adoption.

**RESOLUTION RE: THE TRANSFER OF \$5,931,638 FROM THE  
EDUCATIONAL FUND TO THE DEBT SERVICE FUND  
PURSUANT TO 23 ILL. ADMIN CODE 100.50**

WHEREAS, the Illinois Administrative Code (23 ILL. ADMIN CODE 100.50) authorizes the permanent inter-fund transfer of money to the Debt Service Fund when revenues or other sources of funds are pledged to pay debt service on any long-term debt; and

WHEREAS, this Board of Education finds and determines that it is necessary to pledge Five Million Nine Hundred Thirty-One Thousand Six Hundred Thirty-Eight Dollars (\$5,931,638) in the Educational Fund to pay debt service on a long-term debt, specifically, to pay debt service on the School District's General Obligation School Bonds, Series 2004A; and

WHEREAS, this Board of Education is now authorized to permanently transfer the sum of \$5,931,638 from the Educational Fund to the Debt Service Fund pursuant to 23 ILL. ADMIN CODE 100.50; and

WHEREAS, this Board of Education deems it advisable, necessary and in the best interests of the District that \$5,931,638 be transferred from the Educational Fund to the Debt Service Fund.

NOW, THEREFORE, Be It Resolved by the Board of Education of Geneva Community Unit School District No. 304, Kane County, Illinois, as follows:

SECTION ONE. That the preambles to this Resolution are hereby incorporated by reference into this Section One as if fully set forth and stated herein *verbatim*.

SECTION TWO. That the Treasurer of this School District is hereby directed and authorized to transfer on or before March 31, 2014, the sum of \$5,931,638 from the Educational Fund to the Debt Service Fund.

SECTION THREE. That this Resolution shall be in full force and effect forthwith upon its adoption.
