House Bill (HB) 3 and Graduation Requirements for 2009-2010

The passage of House Bill (HB) 3 requires new graduation requirements that will take effect on September 1, 2009. These new graduation requirements supersede the graduation requirements in 19 Texas Administrative Code (TAC) Chapter 74. Prior to this legislative change, DISD staff was in the midst of conversations relating to the number of credits required of DISD students to graduate on the minimum graduation plan. Currently, The Recommended High School Program (RHSP) is the default graduation plan for all Texas and DISD students. Successful completion of the RHSP requires students to accrue 26 credits for graduation.

Recommended High School Program (RHSP) and Distinguished High School Program (DAP)

The RHSP and the Distinguished Achievement Plan (DAP) outline the total number of credits for graduation and the requirement of 4 credits in the 4 foundation areas of mathematics, English language arts, science, and social studies/economics did not change, however HB 3 changes include:

- Providing more flexibility in the enrichment areas of the RHSP by increasing the number of
 elective credits to 6, requiring one credit of PE, 2 credits of language other than English
 (LOTE), and 1 credit of fine arts; and
- Providing more flexibility in the enrichment areas in the DAP by increasing elective credits to
 5, requiring 1 credit of PE, 3 credits of LOTE, and 1 credit of fine arts
- Credits removed from the requirement are ½ credit of Health, ½ credit of Communications
 Applications, 1 credit of Technical Applications (usually BCIS), ½ credit of PE

Specific Information regarding the graduation requirements for students entering 9th grade before 2007-2008, and the graduation requirements for students entering the 9th grade in 2007-2008 or later is attached.

Minimum High School Program

Under state law, permission to graduate under the minimum high school program must be agreed to in writing and signed by the student, student's parent (or other person standing in parental relation to the student), and a school counselor or school administrator.

Under HB 3, to graduate under the state minimum high school program, students must

- Be at least 16 years of age
- · Have completed 2 credits for graduation in each subject of the foundation curriculum; or
- Have failed to be classified as a 10th grade student one or more times as determined by the school district.

Local districts may continue to adopt additional graduation requirements that go beyond the state requirements for graduation. DISD teachers, counselors, campus administrators, and central office personnel are exploring the possibilities allowing the requirements necessary for the state minimum high school program to serve as the requirements necessary for the DISD minimum high school program. A study of local districts indicates a variance in the number of credits required for graduation on the minimum high school program. 10 district policies were examined in this comparison. The range

of credits required for graduation on the minimum high school program is 22 to 27. Two districts require the same number of credits as Denton ISD, seven districts require less, and one district requires more. The results are shown in Table II below.

EARLY GRADUATION

Students may graduate at the end of any semester if all requirements for graduation have been met. Arrangements must be made with the principal and counselor prior to the start of the student's last semester. A conference between the parents, principal, and the student shall be required before approval is granted. Schedule changes shall not be allowed once the final semester has begun.

Early graduates shall be given a letter of high school completion upon the completion of requirements for graduation if this is before the regular period for class graduation. Early graduates may participate in the graduation exercises at the end of the school year, provided all arrangements have been made and approval by the principal has been obtained. Early graduates may have their high school diploma mailed to them if they elect not to participate in the graduation exercises.

GRADUATION PROGRAMS

Grade 9 students entering District schools will be required to enroll in the Recommended or in the Advanced/Distinguished Achievement Program. Permission to graduate under the Minimum Program will be granted only if certain criteria are met and an agreement is reached among the following persons:

SPECIAL EDUCATION SERVICES

When proposing graduation, the admission, review, dismissal (ARD)/individualized education program (IEP) committee shall inform the parent and student in writing that graduation constitutes a change of placement.

When a student has met the minimum credit requirement for graduation as defined in this policy but has not passed the exitlevel statewide assessment, and an ARD/IEP committee deter-

mines that there are continued educational and/or transitional needs, special education services may continue. These services are specified in the student's IEP and must include specific transition goals/objectives and interagency linkages.

If special education services continue, the student may still participate in commencement exercises but shall receive a certificate of participation in lieu of a diploma.

The student shall continue receiving services as specified in the IEP until one of the following results occur, at which time a diploma shall be awarded and services shall cease. [See EIF(LEGAL)]

- Full-time employment, based on the student's abilities and local employment opportunities, in addition to sufficient selfhelp skills to enable the students to maintain the employment without direct and on-going educational support of the District;
- Demonstrated mastery of specific employability skills and selfhelp skills that do not require direct on-going educational support of the District. Employability and self-help skills are those skills directly related to the preparation of students for employment, including general skills necessary to obtain or retain employment;
- Access to services that are not within the legal responsibility of public education, to employment, or to educational options for which the student has been prepared by the academic program; or
- Student no longer meets age eligibility requirements (through age 21).
