Denton ISD – Quarterly Growth Report Rocky Gardner with Templeton Demographics presented the current Quarterly Growth Report for 1Q17. Denton's unemployment rate is currently below 4%. Roughly a quarter of Denton ISD annual home sales fell within Paloma Creek and the district has more than 28,000 planned future lots. Current housing activity is concentrated along the Hwy 380 corridor and Rodriguez Middle School is expected to open this fall with 650 students. Denton ISD can expect an increase of approximately 4,300 students during the next 5 years with 2021/22 enrollment projection: 32,958 students. DISD is projected to enroll more than 37,500 students for the 2026/27 school year.
