- 6) Island Music will provide an invoice to AISD after each residency.

Annette Islands School District agrees to the following terms:

For each Island Music residency that includes Metlakatta, AISD will provide:

1) Lodging for participants (homestays, or use of district housing).

- 2) Transportation for participants if needed (may include transportation to and from the ferry and use of a school van as possible).
- 3) No cost venue options for educational and/or performance events.

4) Guidance/assistance with promoting events to the community.

- 5) Allocation time(s) during the school day for students to participate in educational/performance events.
- 6) Per each residency payment of \$750 to be paid when itinerary for visiting artists is confirmed.

Agreement Duration/Renewal:

March 25, 2025 - March 24, 2026, with a review in February 2026 for extending for the following year.

*2 residencies yearly is most likely, so a total school-yearly donation of \$1500 to KAAHC to offset our costs.
