#### BACKGROUND INFORMATION


On June 1, 2009, the Board adopted current policy language regarding Authority to Obligate the District (Board Policy DJ), which updates the School District's Public Contracting Rules in accordance with State Recommended Model Rules. Appropriate bidding procedures and Public Contracting Rules have been complied with before recommending the attached contract for Board approval. The following authorization of contract, subject to available budget appropriations, is a routine Board action that appears under the consent grouping of the Board agenda.

**PROJECT NAME:** Capital Center Building Improvements

**PROJECT TIMELINE:** 10/2014 - 09/2016

**PROJECT BUDGET:** \$13,508,130

**PROJECT SCOPE:** The east section of the building is in need of a new roof and associated seismic upgrades. A new HVAC system is needed to replace rooftop units which are very energy inefficient and have far exceeded their lifespan. Building improvements will be made to house the School of Science and Technology and the SPED Transition Services program spaces will be expanded.

Create an additional data center in the Capital Center building. It will be a state-of-the-art center and will house the District's servers and data storage medium to support the entire District network. Creation of this data center includes purchasing of new servers and hardware, UPS, emergency generators, fire protection, security access and video surveillance camera systems.

New HVAC equipment and controls for the existing Health and Science School and Nutrition Services program areas. Miscellaneous repairs.

Building improvements will be made to house the Deer Park/Bridges program and relocate the professional development and storage spaces for Teaching and Learning within the building.



**PROJECT TIMELINE:** 1/2015 - 9/2017

**PROJECT BUDGET:** \$25,000,000

**PROJECT SCOPE:** Construct new two-story K-5 school building with a total capacity of 750

students.

**CONTRACT NAME:** North Bethany Elementary -

Construction Manager/General Contractor Services

**SOLICITATION METHOD:** Request for Proposal (RFP# 15-0036)

**CONTRACT TIMELINE:** 12/2015 – 9/2017


**CONTRACT SCOPE:** Provide contractor preconstruction services during the design phase of the

project. Approval to award construction work will be requested at a later time.

**CONTRACT AMOUNT:** \$ 66,800

**PROJECT NAME:** Security Upgrades

**PROJECT TIMELINE:** 11/2014 - 10/2017

**PROJECT BUDGET:** \$10,000,000

**PROJECT SCOPE:** Complete security retrofits in existing buildings by installing improvements such as; security cameras, remote entry door unlatching, keyless entry, visitor routing control, etc., as determined by a site-by-site analysis of needs compared to the security standard.

**CONTRACT NAME:** Design Services - District Security Upgrades, Phase 1 / 1A, group 2 & 3

schools

**SOLICITATION METHOD:** Request for Proposal (RFP# 15-0032)


**CONTRACT TIMELINE:** 12/2015 - 10/2017

**CONTRACT SCOPE:** Design of security upgrades to the 36 remaining schools in the district. Upgrades to include keyless entry hardware and card-readers, remote entry door unlatching, lock-in / lock-out control, safety glazing film and entry vestibules for visitor control at schools without existing vestibules.

**CONTRACT AMOUNT:** \$ 409,082

**RECOMMENDATION:** Authorization of award of contract to Dowa|IBI

PROJECT NAME: FutureReady Schools Year 1 - Student Chromebook Devices, Carts and Cases

**PROJECT TIMELINE:** 12/2015 – 2/2016

**PROJECT BUDGET:** \$ 3,800,000

**PROJECT SCOPE:** Provide Chromebook devices for students in grades 4-12 at the 15 FutureReady schools and the Early College program. Meadow Park and Cedar Park middle schools will receive a 10% deployment of Chromebook devices. Cases for iPad devices ordered separately and carts for both iPad and Chromebook devices will be distributed.

**CONTRACT NAME:** FutureReady Year 1 Student Chromebook Devices

**SOLICITATION METHOD:** Cooperative Purchase Agreement

**CONTRACT TIMELINE:** 12/2015 – 1/2016


**CONTRACT SCOPE:** Purchase of Chromebook devices, cases for iPad devices, and carts for both

Chromebook and iPad devices.

**CONTRACT AMOUNT:** \$ 3,800,000

**RECOMMENDATION:** Authorize Award of Contract

PROJECT NAME: FutureReady Schools Year 1 - Student iPad Devices, Carts and Cases

**PROJECT TIMELINE:** 12/2015 – 2/2016

**PROJECT BUDGET:** \$ 800,000

**PROJECT SCOPE:** Provide iPad devices for students at the 15 FutureReady schools. Meadow

Park and Cedar Park middle schools will receive a 10% deployment of iPad devices.

**CONTRACT NAME:** FutureReady Year 1 Student iPad Devices

**SOLICITATION METHOD:** Cooperative Purchase Agreement

**CONTRACT TIMELINE:** 12/2015 - 1/2016

**CONTRACT SCOPE:** Purchase of iPad devices for FutureReady Year 1 Schools.

**CONTRACT AMOUNT:** \$ 800,000

**RECOMMENDATION:** Authorize Award of Contract

FUNDING SOURCE: 2014 Bond Issue Fund
