This course satisfies the requirements for mandatory board member training per 105 ILCS 5/10-162, including instruction in education and labor law; financial oversight and accountability; and fiduciary responsibilities. Every new school board member elected or appointed must complete this training within the first year of the first term. Performance Evaluation Reform Act (PERA) training is included to prepare board members for their role in implementing the "optional alternative evaluation dismissal process," as required per 105 ILCS 5/24-16.5.


