The following comprises **BNM Professional Consulting Services, Inc. (BNM)** proposal to provide Speech-Language Pathology Services to **School District #152. BNM** has serviced birth to 3 year olds, school aged students 3-21, and adults. Students with physical, neurological, mental, behavioral or educational disabilities, and with articulation, voice, fluency, hearing or language deficits have received service from us in schools, hospitals and nursing homes. The services provided include screenings, evaluations, therapeutic interventions and consultation to staff and parents, participation in multidisciplinary conferences, individual education program meetings in addition to completion of all required documentation, including completion of Medicaid documentation.

BNM budget costs is firm for the duration of the service agreement and the undersigned warrants that she is duly authorized to bind the entity submitting this proposal to fully perform all duties and deliver all services in accordance with the terms and conditions as set forth therein.

BNM Speech-Language Pathologists are supervised on-site on a quarterly basis by one of the supervisors or the Director of Clinical Services. Supervision will function to assure quality clinical services, documentation and evaluations to meet standards set forth by the American Speech-Language-Hearing Association. If deficiencies are identified, follow-up visits within 30 days will be completed to assure compliance with the intervention correction plan. Staff members are required to complete CPR Training.

Professional and general liability insurance is provided by **BNM** to cover all of its salaried employees.

BNM will provide speech-language services to **School District #152** at a rate of \$81.00 per hour. This contract will commence on or about the week of August 2015-June 2016. Payment for services will be due within 30 days after the receipt of the invoice. Required dates of service per week will be designated by the Special Education Director by August 2015.
