NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR MIDWEST CENTRAL SCHOOL DISTRICT #191

- I. A public hearing to approve a proposed property tax levy increase for Midwest Central Community Unit School District 191 for 2024 will be held on December 5, 2024 at 6:30 p.m. at Midwest Central District Office 1010 S. Washington St., Manito, IL 61546.

- II. The corporate and special purpose property taxes extended or abated for 2023 were \$5,184,482.

The proposed corporate and special purpose property taxes to be levied for 2024 are \$5,657,991. This represents a 9.13% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for 2023 were \$910,866.

The estimated property taxes to be levied for debt service and public building commission leases for 2024 are \$910,000. This represents a 0.000934% decrease over the previous year.

- IV. The total property taxes extended or abated for 2023 were \$6,095,349.

The estimated total property taxes to be levied for 2024 are \$6,567,991. This represents a 7.75% increase over the previous year.
