eSports News

The board took some heat when it established an esports program where kids play video games at school. Some people in our community could not see any benefit to it whatsoever.

Two members of our esports team just agreed to letters of intent to play esports at Northwestern College in Orange City for \$25,000 scholarships each.

Projection System for Luick Auditorium

At the January meeting, the school board approved the replacement of the video projection system for Luick Auditorium. I had one concern regarding whether or not the 4K projector with 7,500 Lumens would be as bright as a lower resolution projector with 10,000 Lumens. I was assured that the higher resolution of the 4K projector would provide a brighter screen. I put in the order for the 4K laser projector.

The board asked about warranties for the projectors. The standard warranty from Digital Projection is three years on the unit. Our installer offers one year of parts and labor on their work with the manufacturer's warranty.

Protections for Staff from Retaliation

Belmond-Klemme employees enjoy several layers of protections against any form of retaliation by other employees, administrators, or school board members.

School board policy 104, the Board's Anti-bullying/harassment policy defines internal organizational protections for employees against retaliation. The policy states, "Any school employee found to have retaliated in violation of this policy shall be subject to measures up to, and including, termination of employment." The policy goes on to explain how allegations will be investigated and protections are in place to ensure fair and unbiased investigations.

Moreover, the State of Iowa has protections in place. The Iowa General Assembly has adopted narrow statutory protections for certain activities. Employees who engage in protected activities (usually filing a complaint or testifying) are protected from retaliation. If a public employee reasonably believes there has been a violation of a law, mismanagement, a gross abuse of funds, an abuse of authority, or a substantial and specific threat to public health and safety, they can report it to an appropriate authority. Iowa Code § 70A.28.

A public employee who believes they have suffered adverse action should file a claim within 30 days with the public employment relations board or within 30 days of the ruling by the ombudsman office.

This is a significant reason why it is essential for employees to follow the official channels of communication defined in school board policy 307 or policy 401.4.

If any employees were to truly fear retaliation, you can say as a school board member that you are in a position to protect them from any such retaliation. If they feel the board cannot protect them, they may also take their complaints of retaliation directly to the state.
