BACKGROUND:

Request for Proposal (RFP) 12-0085 was e-mailed to 60 Contractors registered with the District's Purchasing Department and published on the District's web site. The scope of work requested qualified Speech Language Pathologists (SLPs) and Speech Language Pathologist Assistants (SLPAs) to be used on an as needed/as required basis throughout the District. Twenty-four Contractors responded with proposals; two Contractors were deemed not qualified per the requirements of RFP 12-0085.
