5. SUPERINTENDENT REPORTS

A. Adjunct Teaching Positions

By state law, we can grant someone a teaching license and allow them to become an adjunct teacher. The person must have been in the profession for four years and have the required number of hours of service in that profession to become an adjunct teacher. We have two positions that we would like to renew: the physical education/weights/strength position at the HS and the Creekside art teacher.

B. Franklin Community Virtual Schools

The team partners are Indiana Online for grades 5-12 and EdOptions Academy for grades K-4 (in the 25-26 school year, 5th grade will move to EdOptions). By October count day, FCVS had 120 students enrolled, and by the end of the second semester, enrollment increased to 145 students. Achieved an 89.97% attendance rate, 100% IREAD pass rate, and a graduation rate of 60%. Attended the DLAC conference, which was completely dedicated to virtual learning. Learned how to work with homeschool families and how to serve those kids. Met an NCAA contact at the conference and was able to reach back out again to resolve why we were originally denied NCAA eligibility (allows students to go from virtual school to play D1 athletics in college). With this push back to the NCAA, we were able to get NCAA-eligible approval, and they changed the way their policy works for other schools that look like us. Looking forward to next year.

B. Public Hearing for Amended Bus Replacement Plan 2025

The regular meeting was closed at 6:48 pm, and the public hearing opened.

This plan is to purchase 18 buses in total. Two of these buses are electric (grant subsidized). Our current average bus is 9-1/2 years old. We have 37 buses that are 12 plus years old. After this purchase, our average will go down to 5.4 years old and only 14 buses will be 12 years or older. We obtained pricing through CIESC. Tina Jobe requested approval of the resolution for the amended bus replacement plan.

Hearing no public comments, the public hearing was closed and the regular meeting opened back up at 6:52 pm.

C. Critical Response Group

Benji Bett requested approval of the Critical Response Group (CRG) proposal. CRG is proposing a mapping solution that will enable better communication during an emergency. CRG combines accurate floor plans, high resolution imagery, emergency response pre-planning, and a gridded overlay into one map. Micro CRGs come standard with labeling for floor levels, facility nomenclature, doors/access points, main utility shut-offs, roof access points, Fire Alarm Control Panels, security key boxes, IEDs, and trauma kits, and are used to coordinate emergency response inside a structure. Macro CRGs come standard with labeling for buildings, parking lots, athletic fields, roadways, access points, and other key landmarks around the property. MACRO CRGs are used to coordinate events exterior to the structure.

A. FCVS 2025-2026 School Calendar Grades K-5

This calendar is a draft for FCVS grades K-5.

B. EverDriven Technologies, LLC Transportation Agreement

This agreement allows us to coordinate transportation to and from school as needed for those students who need the least restrictive environment. We get charged per service.

C. AstroTurf Field Turf Agreement

AstroTurf would provide us with a Rhino maintenance proposal for services to be performed in 2025 (\$4,000). All programs cover preventative maintenance procedures, which will include the reattachment of minor inlays/field markings or seams.

D. Beanstack Agreement

Beanstack is a customizable reading challenge platform with easy-to-use challenge templates, a mobile app, computer-based, and diverse book recommendations. To fund it, we will combine district funds with library funds to purchase.

E. Mindful Growth

Mindful Growth would conduct a maximum of 75 psychoeducational evaluations during the 2025-2026 school year. After the evaluation, they provide a recommendation for eligibility for special education and related services.

F. Abnormal Email Security

Email remains one of the most ubiquitous forms of digital communication. Our current filter looks for terms and technology and are looking for something new. Abnormal looks for trending within the email (who it is from, how they speak, is this a normal context they use, is this a normal way they phrase things). Instead of just looking for email addresses and poor wording, it is uses artificial intelligence. Right now, Abnormal is in line with our current email system but it is not doing anything with what it is checking. The Abnormal price for staff only is \$12,600 per year.

G. Handbooks 2025-2026

Changes to the 2025-2026 school year handbooks are in the summary of changes for each building. There have been some changes through legislation in the Indiana Code regarding attendance. We will receive our updated attendance policy from CCHA around June 15th.
