# GENEVA COMMUNITY UNIT SCHOOL DISTRICT NUMBER 304 227 NORTH FOURTH STREET, GENEVA, ILLINOIS RECORD OF PROCEEDINGS OF A REGULAR SESSION OF THE BOARD OF EDUCATION

The Board of Education of Community Unit School District Number 304 met in a regular session on Tuesday, October 11, 2011, at 7:00 p.m. at Coultrap, 1113 Peyton, Geneva, Illinois.

The meeting was called to order at 7:00 p.m. by President Moran.

The President led everyone in the Pledge and reminded them to sign the attendance record.

# 3. RECOGNITION, AWARDS, PRESENTATIONS, PUBLIC HEARINGS

3.1 Red Ribbon Week Activities

Geneva Coalition for Youth - Julie Pouilly GHS Students Against Destructive Decisions - Erin Taylor & Kelley Dunlop (Lisa Gillette, GHS Health Educator/Advisor & Becky Furnish)

Representatives from the Geneva Coalition for Youth and S.A.D.D. summarized the events and activities planned for this year's Red Ribbon Week which is October 22 - 30. This year's theme is "It's Up to Me to BE DRUG FREE." The students emphasized that most teens are not using drugs, rather they are spending time with their family and friends. This year, emphasis is on reducing/managing stress and synthetic drug use awareness. Community members were encouraged to participate in the annual Candlelight Vigil on Sunday, October 23rd at 7:00 p.m. at City Hall. Other activities planned include a collection program for expired and unused prescription and over the counter drugs; Make-a-Difference Day, a celebration of neighbors helping neighbors; a community food drive; and a Community Celebration and Expo on Saturday, October 29th at Geneva Middle School South. Ms. Pouilly thanked the Board of Education and the District's administration for their support.

The Board thanked Ms Pouilly, the Coalition, and the students for their efforts on behalf of Geneva's children.

3.2 Sodexo Food Service Presentation

Becky Selcke, Sodexo Food Service General Manager, presented an overview of the programs,

activities and initiatives in Geneva's schools. Sodexo's programs include age-appropriate health and wellness educational information for students at each level, expanded efforts to use fresh, locally grown produce, My Mondays meatless menu choices, Health and Wellness Fairs; A to Z Garden Bar; cookouts; recycling programs; participation in community programs; and improving staff and customer safety. They have cut back on offerings that parents felt were not healthy choices for students and student health and well-being continues to be a top priority.

Board discussion, comments, questions: there is a growing number of children with allergies and national data indicates that eight percent of all U.S. households have a child with allergies - what has Sodexo done relative to finalizing the development of a national database that all their school districts could access for information regarding their products (we continue to work on the software and hope to have this resource available for parents this year); want to see food allergies addressed in next year's Sodexo presentation to the Board; many of the menu entrees contain cheese, chicken, hot dogs and other unhealthy items - how do we get more healthy choices for our students and why do the healthy choices that are available cost more (we have transitioned to low fat versions and offer fresh fruit and salads daily which cost the same as an entree); would also like to see less carbohydrates on the menu and more healthy options that cost less (will look at options with less carbs); many carbs can be offset by fiber content, perhaps Sodexo could add a product's fiber count to their online nutritional information; allergies are a huge issue that needs to be addressed by our food provider; this has been a good discussion and want to thank our food service General Manager for the many changes and improvements that have been made and for all the extra programs, projects and services that she provides; have spent time with our Sodexo General Manager and would encourage other board members to do the same to see her program; have three kids who love the food, especially the corn dogs (they are chicken corn dogs).

The Superintendent reported on the following: last week's Joint PTO meeting where lots of information and ideas was shared; the high-level of student involvement in the high school's homecoming activities; his appreciation for the staff and administrators who created the professional development activities for last Friday's institute day; all-day testing which will occur at the high school on Wednesday, October 12th; notification that the District had received the SchoolSearch Bright A+Award for the fifth year in a row; and notification of the District's Standard and Poor's AA+ rating. The Superintendent thanked the Board for its leadership.

Comments included: thanks to the Assistant Superintendent for providing information on a question raised at the recent public forum - am interested in keeping property taxes low and my motto is "cut overhead, keep teachers" - want to know why the Board is incurring additional debt to reduce total debt by only about \$400,000 when the debt could be called and could save \$3.3 million or eliminated the debt - hope the Board will cut long-term debt overhead and answer that question before incurring more debt.
