CONNECTION TO THE DISTRICT STRATEGIC PLAN:

This purchase is in keeping with the Lansing School District's mission of providing educational excellence in a safe and nurturing environment, as well as protecting the school district's assets. This recommendation supports the Lansing School District Sinking Fund.

COMMENTS:

The Christman Company received proposals for Dwight Rich HVAC Renovations. Four vendors submitted a proposal for Work Category 27 Mechanical & Plumbing. The Review Team's evaluation and Post Bid Interviews determined WM Floyd Heating Co. is the most responsive and qualified bidder.

RECOMMENDATION(S):

It is recommended that a contract be authorized for Work Category 27: Mechanical with WM Floyd Heating Co being the lowest responsive and qualified bidder, in a total not to exceed **\$1,864,700**.

Note: for project scope changes that arise with respect to the work of this contractor, the Superintendent of Schools will authorize changes up to \$50,000 and report those changes to the Board of Education for acceptance. Change issues exceeding \$50,000 will be submitted to the Board of Education for approval before authorization by the Superintendent.
