

# Child Nutrition CSP 130117 for Commodity Processing

February 26, 2013

## **SUMMARY:**

This item requests approval of CSP 130117 for Child Nutrition Commodity Processing for the 2013-14 school year.

## **BOARD GOAL:**

**VI. Growth and Change...a.** Demonstrate effective and efficient management of district resources.

## **PREVIOUS BOARD ACTION:**

On February 28, 2012 the Board approved the 2012-13 proposal as recommended.

## **BACKGROUND INFORMATION:**

Proposers submit all of the services they provide. However, our district does not use all of the types of processing. The types used are noted on the summary sheets.

Proposals were submitted by Advance Pierre, Alpha Foods, American Foods Group, American Pride Seafood, Barrel O Fun, Bosco's Pizza, Café Favorites, Cargill Meat Solutions, Cavendish Farms, ConAgra Foods, ConAgra Foods – Lamb Weston, ES Foods, Horizon Snack Foods, Jennie-O, JTM Provisions, Land O Lakes, Lings, McCain Foods, MCI Foods, Micheal Foods, Nardone Bros, National Food Group, Pilgrim's Pride, Red Gold, Quantum Foods, SA Piazza & Assoc, Schwan's Food Service, Simplot, Sunwise Foods, Tyson, Uno Foods, and Wawona Frozen Foods.

Pricing was submitted as a Fee for Service or Net off Invoice. It will depend upon the commodities actually processed as to how much will be spent.

Pricing was reviewed and each category of processing was given to the processor with the best over-all pricing.

## **SIGNIFICANT ISSUES:**

Commodity Processing for the 2013-14 year must be approved by the end of February 2013.

The best overall pricing was submitted as follows;

Tyson Food – Beef, Jennie-O – Turkey, Tyson Food – Chicken, JR Simplot – Potatoes, Alpha Foods - Mozzarella Cheese, Land O'Lakes – Barrel Cheese, ConAgra Lamb Weston – Sweet Potatoes, and Wawona - Strawberries.

Costs will be borne by the Child Nutrition Budget.
