Attached are the General and Capital Projects Fund Budget Amendments.

The General and Capital Projects Fund Budget Amendments for the Student Activity Center Football Stadium includes: \$241,200 for approximately 1,000 additional aluminum bleacher seats, \$1,050,000 for approximately 540 additional parking spaces, \$188,997 for approximately 1,472 additional mounted chairs with plastic backs and plastic seats, and \$19,803 for contingency funds.

Also, the General Fund Budget Amendment includes: \$800,000 for 101-Food Service and realignment of funds for 199-Maintenance and Operations.
