



ATHLETIC TRAINING SERVICES AGREEMENT

This agreement between Orthopedic Rehab Specialists and Stillman Valley High School is made and entered into this __ day of _____ 2025 and represents like terms and conditions for three separate school years 2025-2026, 2026-2027, 2027-2028 and stipulates the following:

1. A certified and licensed athletic trainer, namely Aaron Engel, will be available to provide athletic training services to the high school, five days a week, on a regularly scheduled basis at times mutually agreed upon by the athletic trainer, athletic director and Orthopedic Rehab Specialists. Services will be provided at the high school.
2. The primary responsibility of the certified athletic trainer will be to screen injuries, refer those requiring diagnosis and treatment to the appropriate physician, and to recommend procedures for prevention, assessment and treatment of student athletic injuries.
3. Services provided by the certified athletic trainer are covered under the Orthopedic Rehab Specialists Professional Liability Insurance (Policy 0684725794).
4. In addition to the services described in #1, the licensed athletic trainer will also be available for 5 hours of coverage for each of the following events:
 - A. Coverage of all HOME Varsity sporting events with the exception of Cross Country, Golf and Bowling;
 - B. All HOME and away Sophomore and Varsity Football games, and HOME Freshman Football games;
 - C. If Junior Varsity plays before a Varsity event, coverage will be provided for the Junior Varsity event with the exception of soccer. If Varsity Soccer plays before the Junior Varsity, then the Junior Varsity game will be paid by the PER EVENT Fee schedule (below);
 - D. Any isolated Freshman or Junior Varsity game will be paid by the PER EVENT Fee Schedule;
 - E. Post-season HOME events that Stillman Valley hosts i.e. Regional and Sectionals.
 - F. If more coverage is needed, the PER EVENT Fee Schedule will be paid directly to the athletic trainer by check at the end of the event.
5. Orthopedic Rehab Specialists and the high school recognize the athletic trainer's responsibilities include counseling student athletes on injury prevention, athletic training, and rehabilitation and are shared with parents, physicians, coaches and individual student athletes.
6. The agreed upon fee for school years 2025-2026, 2026-2027, 2027-2028 will be \$34,000.00 annually made payable to Orthopedic Rehab Specialists in three installments of \$11,333.34, \$11,333.33, and \$11,333.33 payable at the end of every season (Fall/Winter/Spring).
7. The high school is responsible for providing adequate space for the certified athletic trainer to effectively and safely perform duties as well as furnish supplies. The high school will provide the certified athletic trainer with the following equipment:

- A. An exam table.
 - B. Phone access.
 - C. Any supplies necessary for the certified athletic trainer to safely fulfill his obligation to the school and the student athletes (i.e. ice, tape).
8. Orthopedic Rehab Specialists will proudly provide athletic training services to Stillman Valley High School and as a result will promote this relationship throughout the school year in the following communication pieces.
 1. Orthopedic Rehab Specialists' company banner prominently displayed in the high school gymnasium throughout the entire school year as well as at the baseball field, football field and soccer field. A digital ad for Orthopedic Rehab Specialists will be displayed on the high school's digital score board. All of this signage and promotion will be paid for by the high school. Artwork will be provided by Orthopedic Rehab Specialists for production of signs and ads.
 2. Orthopedic Rehab Specialists will proudly promote the athletic training services relationship with the high school on its www.orspt.com website.

PER EVENT Fee Schedule

Orthopedic Rehab Specialists is pleased to assist the high school for additional events outside of the above agreed upon schedule. The athletic trainer's schedule must be arranged as least two weeks in advance to provide coverage of events. It is understood that the school will provide any supplies necessary for adequate event coverage (i.e. ice, tape). The athletic trainer should be paid in a similar fashion to game officials, by check at the end of the event.
