I additionally propose greater "grow your own" programs enhancing our current employees advancing their skills and certification/licensure.

Being available to visit individual School and Education Service Districts on an individual basis - as well as during the regional OSBA meetings. Additionally, creating a monthly newsletter sharing both OSBA information and highlighting activities from districts in the Gorge Region, even to spotlighting Board members, Educators and even top students.
